2. Circumstances that led to the apprehension:
 - a. Please be informed that on July 16, 2023 pm at around 5:00 pm until 6:00 am of July 17, 2023 the CENRO personnel with the assistance of PENRO chief MES Arnel C. Gamutia conducted an intensified manning of checkpoint at Dipulao FPMS situated at Sitio Dipulao, Bgy. 6, Coron Palawan. That around 5:06 in the morning of July 17, 2023 the team intercepted a Topdown/Toratora passing the FPMS loaded with six (6) sacks of charcoal.

During investigation, Forester Gamutia asked the legality of the forest products however Mr. Elbat failed to present his permit which is clearly a violation to our environmental law, rules and regulation. Thus, after the team informed his violation and his rights, forest products as well as the vehicle which is the accessory of the illegal activity were apprehended pursuant to DAO 97-32. Also, apprehension receipt was handed to Mr. Elbat as part of the apprehension process.

Apprehended forest products and vehicles were delivered to this office for safekeeping and custody.
