Rodne Rodina Galicha a member of PAMB, posted a photo (screen grab from a video posted publicly) a photo of me with vandalism "Kiss the Wall" though he put a disclaimer stating that "The person in the photo may not be the one who committed vandalism, but we will surely invite them to cooperate in the investigation"

Understand that my face is covered on the photo but still recognizable by my colleagues because there's a name on the right side of my shirt also my friends knew about this because the video is publicly posted.

I immediately message Mr. Galicha to which he apologized. However the admin of Mt Guiting-guiting FB page - Christian G. Rafol, continue to post the photo with a different caption as if he is insinuating that the Lady at the photo is at fault.

As a proper decorum, I am raising this issue to your department. People are falsely accusing me of the crime without any proper investigation.

According to Christian G. Rafol the online photo is meant to spread awareness but it doesn't look that way. If his intention is to let the public know about prohibition there's another photo that he can share. He claims that his intention to include on that photo is because "maganda raw at nakangiti ako sa Kiss the wall" this conversation was uttered over the phone.

Is there any sanction given to any members of your agency and the mountaineering group of Sibuyan?

Let me know if there are information that you find unclear. I am happy to share it to you and if the investigation is on-going regarding the vandalism I am more than willing to cooperate.
