The new Extended Producer Responsibility (EPR) Act of 2022 or RA 11898 is an amendment to RA 9003 (Solid Waste Management Act). The policy aims to enhance the current solid waste management systems through a responsibility mechanism that engages producers throughout the life cycle of their product, including its end-of-life stage. The goal is to recover plastic packaging that reaches the market and prevent it from going to landfills or nature. However, many private companies and LGUs still need further clarity on how this affects them and what they need to do.

This two-day virtual seminar will provide participants with a clear understanding of the EPR scheme and the Waste Diversion Credit, as well as the specific roles and responsibilities of the Producer Responsibility Organization (PRO), the obliged enterprises, the certifying bodies, the waste diverters, the national government, and the local government units. It will also feature innovative technologies and procedures for recycling or converting waste to fuel or energy. Attendees will also have an opportunity to consult the experts.

The seminar will highly benefit private companies, pollution control officers, PENROs, CENROs, MENROs and waste management companies. The speakers are waste management and environment experts who have extensive experience in helping companies and LGUs achieve an environmental and integrated approach to solid waste management.
