SUBJECT	:	TRAINING DETAILS AND PROGRAM OF ACTIVITIES

#### I. Rationale

The PMNP adopts a bold, multi-sectoral nutrition approach to deliver a coordinated package of nutrition-specific and nutrition-sensitive interventions across varying LGU platforms together with a harmonized social and behavior change communications (SBCC) strategy.

The project will prioritize LGUs with the highest burden of childhood stunting based on the best available data. Primary project beneficiaries will comprise children under five years old (with attention to children under two years who will be reached by project activities before stunting becomes largely irreversible), as well as pregnant and lactating women in LGUs prioritized for PMNP support. There are 14 identified target areas in the MIMAROPA region, this includes 7 municipalities in Occidental Mindoro and 7 municipalities in Romblon.

To manage the project, the PMNP Regional Project Management Office will take the lead on providing supportive technical oversight to the priority areas in the region, administer supportive regional project implementation per the Regional PMNP Annual Work and Financial Plan (WFP), support the convening of RTWG and RPMOs, documentation of meetings, supporting financial management, procurement, and mobilization of logistics/inputs and other administrative arrangements.

To achieve the PMNP development objective of increasing the utilization of a package of nutritionspecific and nutrition-sensitive interventions and improve key behaviors and practices known to reduce stunting in target LGUs, the RPMO shall be equipped with technical knowledge on the overall process implementation of the PMNP Components (1&2), project monitoring and evaluation, project financial management, especially the verification of the Performance-Based Grants Accomplishments, and Safeguards Policies. Since the PMNP will build on a community-based approach to mobilize the target communities and support critical behavioral change for improved nutrition outcomes, the RPMO Staff are expected to acquire the technical skills on local level plan implementation, coordination, and project management, while working alongside the RTWG, DOH, DSWD, and partner agencies in harmonizing the multisectoral approaches of the project in the LGUs.

In relation to this, the PMNP Regional Project Management Office will conduct the Technical Training on Project Implementation on July 10-14, 2023, in Metro Manila to provide them with the technical skills and knowledge on the operational management of the PMNP.
