(*Malayopython reticulatus*) IN BARANGAY CAWIT, BOAC,  
MARINDUQUE**

Please be inform that on June 06, 2023, the undersigned personnel of Monitoring and Enforcement Section assisted in the turn-over of one (1) Reticulated Python by Mr. Eric L. Oria of Barangay Cawit, Boac Marinduque. According to International Union for Conservation of Nature (IUCN) it is identified as Reticulated Python (*Malayopython reticulatus*) and a least concern species.

The undersigned immediately facilitated the documentation of the said wildlife. The python was approximately 1.5 meters in length and weighs 3.0 to 4.0 kilograms. Based on visual observation it has no signs of injury or fracture on its body thus it is physically fit to release to its natural habitat. On same day the said python was turn-over to Forester II Danilo Martinez of Conservation and Development Section.

- Regional Special order No. 005 series of 2022. Deputation of selected municipal police officers as wildlife enforcement officer (WEO) within the administrative jurisdiction of PENRO Marinduque.

2. Please be informed that on June 2, 2023 at about 10:15 A.M. PCMS Roy M Inciong, Investigator/ Deputized WEO turned-over a juvenile Reticulated Python (scientific name Malayopython Reticulatus) with blotchy, net-like color pattern covering her body consisting of white, tan, brown, yellow, and red scales and was received by Mr. Danilo Lopez Martinez, Forester 2 and Mr Ricky De Luna Pereda, Forest Technician 1 of PENRO Marinduque. Said python was discovered hiding inside a concrete hollowblock near his property while cleaning his surroundings at Purok River Side-A, Barangay Candahon, Mogpog, Marinduque. The python was measured two (2) feet in length and 1 1/2cm in diameter. PCMS Inciong, subsequently turned-over said snake to PENRO Marinduque for proper disposition. (see attached pictures).

On the same day at about 10:45 in the morning PCMS Roy M Inciong/Deputized WEO posted posters at Mogpog public market, Market Site, Mogpog, Marinduque regarding the list of threatened Philippine Fauna and their categories established under DENR administrative order 2019-09. It shall be unlawful to any person, group or entity to collect and or trade threatened with fauna listed hereof unless such acts are covered by a permit issued by the DENR in accordance with existing wildlife laws (R.A. 9147), rules and regulations.




