ACCOMPLISHMENT REPORT OF THE MARINDUQUE
WILDLIFE RESCUE CENTER**

Submitted are the enumerated activities that were undertaken during the second quarter, to wit;

1. That the maintenance and protection of the Marinduque Wildlife Rescue Center (MWRC) is a continuing activity being undertaken through periodic monitoring and supervision.
2. That a caretaker was hired to sustain the cleanliness of the center, maintained/repaired damaged facilities, regularly fed the monkeys out of the purchased food supplies and promotes hygiene in the cages to avoid pests and deceases.
3. That food supplies were purchased and delivered to the Rescue Center. The caretaker is feeding the monkeys regularly.
4. That on May 2, 2023, a ten (10) years old male Philippine Long-Tailed Macaque was turned-over to Mr. Amado T. Mortel Jr., an employee of PENRO Marinduque. The Long-Tailed Macaque was owned by Mr. Jayson Luna of Barangay Laon, Mogpog, Marinduque. Mr. Luna decided to surrender the pet monkey because he was not able to take care of it. The Macaque undergone medical check-up before it was transferred to the Rescue Center by Dr. Eugene Anthony J. Rozal, DVM of Provincial Veterinary Office (PVO). Also, administered tranquilizer to avoid stress during the trip of the monkey to MWRC for custody, which was delivered by Forest Protection Officers (FPO) Tristan Joshua O. Saet and Jake F. Valencia.
5. That on June 2, 2023, the undersigned and Forest Technician (FT) Ricky DL. Pereda responded on the telephone call from PCMS Roy M Inciong regarding a juvenile Reticulated Python (*Malayopython reticulatus*) surrendered at Mogpog Municipal Police Station (MPS), Mogpog, Marinduque. Upon instruction of the Chief Technical Services Division (TSD) and Chief Conservation and Development Section (CDS), the above mentioned Technical Staff immediately proceeded to

Mogpog MPS to retrieve the juvenile Python. Accordingly, the snake was caught inside the house of PCMS Inciong in Barangay Candahon, Mogpog on May 20, 2023. It has a body length of eighty five (85) centimeters and a body weight of one hundred eighty five (185) grams. Prior to the released, checking of the condition of the Python was done. The snake was in good condition and released in the wild at around 11:12 AM in Barangay Ihatub, Boac.

6. That on June 6, 2023, another Reticulated Python was turned-over by Mr. Eric Orea. Accordingly, the adult Python was captured in the butterfly farm located in Barangay Cawit, Boac. The snake has a body length of almost three (3) meters and body weight of eight (8) kilograms. Based on the physical check-up conducted by the In-Charge of the Office of the PENRO and Chief TSD, the snake was healthy and fit to be released. Early in the morning of June 7, 2023, the snake was traveled to Marinduque Wildlife Rescue Center (MWRC) and released it at exactly 8:54 o'clock in the morning.
7. That the unit had performed other duties and responsibilities as assigned by the OIC, PENR Officer, like the maintenance of seedlings replacement for cutting permit that were turned over to the Rescue Center. To date, a total of 88,760 various indigenous seedlings are being maintained by the caretaker in the said area.

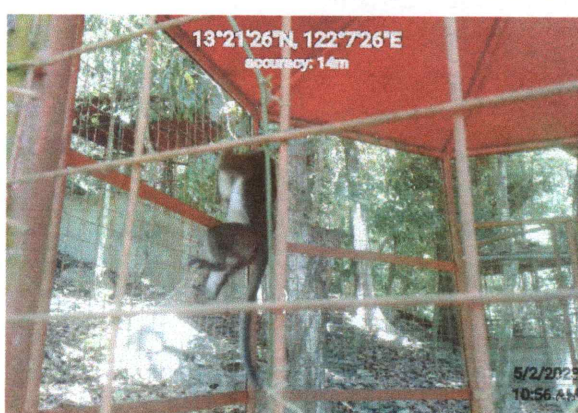
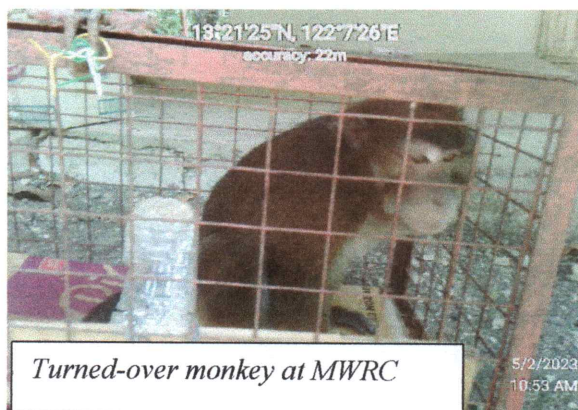
