Respectfully submitted herewith is the evaluation of the BPR Management Office pertaining to the copy furnish of letter dated May 16, 2023 addressed to President Ferdinand E. Marcos, Jr. for clarification over an area located at Brgy. Decalachao, Coron, Palawan. Relative thereto, is the report on the matter.

# **Background information**

A letter dated May 16, 2023 was sent by Mr. Mario R. Sarmiento, Chairman of SAMAPA-TFM addressed to the Presidential Complaints Center regarding the request survey a 1,500 hectare-land in Northern portion of Busuanga Airport in Brgy. Decalachao, Coron Palawan within BPR since it was cultivated particularly for about 12 years through farming. In addition, requesting to subdivide an area in Busuanga Palawan with approximately 200 hectares.

The said copy furnished of a letter was received by the DENR CENRO Calamianes Island on May 18, 2023 and was forwarded to BPR Management Office with the instructions to have update on the matter and to verify the actions taken by this office. On the matter the BPR Management Office have evaluation on the document on hand pertaining the letter of Mr. Mario R. Sarmiento, Chairman of SAMAPA-TFM.

Prior to the above-letter of Mr. Sarmiento, as per record of this office, a series of request letters was received by the DENR from the group of Mr. Sarmiento such as the following:

- Request to apply for CBFM on their area cultivated inside BPR
  - Letter dated August 05, 2019, regarding the Letter of Intent (LOI) for CBFM Application with 5,000 hectare-land in BPR;
  - Letter dated August 15, 2019, regarding the application for CBFMP on 5,000 hectares more or less located at portion of Barangays of Decalachao and San Jose Province of North Palawan.
  - Letter dated February 09, 2021, regarding the submission of Technical Description for the request on application of Community Based Forest Management (CBFM) in the areas of Coron/Busuanga, Palawan;
- Request to the DENR on the implementation of EO 75 and subdivision of lands
  - Electronic email dated February 23, 2021, regarding the implementation of the DENR Coron of EO. 75 since the DENR still did not forward their request to DAR;
    - Electronic email dated February 23, 2021, was forwarded to DENR on February 26, 2021;
  - Electronic email dated June 23, 2021, regarding the follow-up on the request letter date February 13, 2021 regarding the implementation of E.O. 75 inside the area of BPR – 1,000 hectares northern part of Busuanga Airport;
  - Electronic email dated July 26, 2021, regarding the request for a copy of Cadastral Survey at Brgy. Decalachao, Coron, Palawan as requirement for subdividing of lands of the office of DAR-MARO of area of Coron/BPR in connection to the implementation of E.O. 75 s. 2019
- Request to survey a 1500 hectares of land and to subdivide a 200 hectares
  - Electronic email dated October 07, 2022, regarding the request in connection to survey a 1,500 hectare-land in Northern portion of Busuanga Airport in Brgy. Decalachao, Coron Palawan within BPR since it was cultivated particularly for about 12 years through farming. In addition, requesting to subdivide an area in Busuanga Palawan with approximately 200 hectares;
  - Letter dated May 16, 2023 regarding the request survey a 1,500 hectare-land in Northern portion of Busuanga Airport in Brgy. Decalachao, Coron Palawan within BPR since it was cultivated particularly for about 12 years through farming. In addition, requesting to subdivide an area in Busuanga Palawan with approximately 200 hectares;

# Information from document of SAMAPA-TFM

On the letter dated May 16, 2023 of Mr. Sarmiento, the following issues and concerns was mentioned:

- a) The group of SAMAPA-TFM is reiterating on their previous request pertaining to their occupied and cultivated area located in the Northern part of Busuanga Airport, which the group recently found out that it was within the Lot 1605 of CAD-1150D with approximately 2,760 hectares. On the matter, the group wants to clarify for their requested 1500 hectare-lot within the Lot 1605 of CAD-1150D with approximately 2,760 hectares;
- b) On the letter it was mentioned that the DENR was not considering their request or did not have actions on said request;
- c) Letter received from the DENR-CENRO-CORON address to one of the Board of Director (BOD) of their group, directing their member to vacate the area he is occupying even though the location of his area is elevated and cattle's of BAI-NBCRDC cannot grazed on said site; and
- d) Thus, they are inquiring the authority on when will be the survey of land that they occupied and cultivated

### **Evaluation**

On the above-mentioned issues and concerns of Mr. Sarmiento, on **item a**, in reference to the letter dated February 28, 2023, of the OIC-Assistant Secretary for Field Operations – Western Mindanao, and Director in concurrent capacity addressed to Mr. Mario R. Sarmiento –Chairman, SAMAPA-TFM of Brgy. Decalachao, Coron, Palawan regarding their request (email) dated October 7, 2022. On the letter, the FMB Director disclosed that the request of the group of SAMAPA-TFM, cannot be granted pursuant to Presidential Proclamation 1387 series of 1975 due to the fact that the requested area occupied and cultivated is within the Busuanga Pasture Reserve (BPR). In addition, it was also mentioned in the letter that the DENR is not mandated to distribute any portion of forestland; rather the DENR can only grant temporary use of forestland through a tenurial instrument on qualified applicants. Moreover, on the letter it was explained that in the case of BPR, pursuant to Presidential Proclamation 1387 s. 1975, the only tenurial instrument applicable is Forest Land Grazing Management Agreement (FLGMA) which complements with the provisions of the reservation (for your reference, please see attached file).

On their concern on **item b and d**, it was evident that the DENR has already actions taken on their numerous letter requests such as the above-mentioned letter dated February 28, 2023. Likewise, the respond of the DENR remains the same, pertaining to all similar request/s for use, utilization, and or/ development of the areas within the BPR, other than pasture/ grazing, shall not be allowed in line with the existing proclamation. Please see all of the attached Letters as response of the DENR on the numerous requests of Mr. Sarmiento of SAMAPA-TFM.

- Request to apply for CBFM on their area cultivated inside BPR;
- Request the DENR on the implementation of EO 75 and subdivision of lands; and

Request to survey a 1500 hectares of land and to subdivide a 200 hectares

Pertaining to the item c, based on the letter, one their member and a BOD Board of Director (BOD) received a letter from DENR-CENRO-CORON directing him to vacate the area he occupied. As per record of this office, recently the only member of SAMAPA-TFM that was subjected to investigation and issuance of notice to vacate by the CENR Office is Mr. Mr. Elbert Tuazon.

The case of Mr. Elbert Tuazon, started from 2021, a series of investigation was conducted by the BPR Management Office for unlawfully occupying an area inside the reservation particularly in the area of So. Tulbuan, Brgy. Decalachao, Coron, Palawan. Based on the evaluation of this office, Mr. Tuazon have no substantial documents to prove that he is entitled to occupy/possess a part of the area within the BPR. Occupation of Mr. Tuazon violates the Presidential Proclamation No. 1387 s. 1975 and Presidential Decree No. 705, as amended, otherwise known as the Revised Forestry Code of the Philippines:

Section 20. No person may utilize, exploit, occupy, possess or conduct any activity within any forest or grazing land xxx, unless he had been authorized to do under a license agreement, license, lease or permit xxx;

Section 78. Any person who enters and occupies or possess xxx any forestland or grazing land or part thereof xxx or refuses to vacate the area when ordered to do so, pursuant to the provisions of Section 53 hereof;

On the matter, this Office has already issued Notice to Vacate dated May 08, 2023 to Mr. Tuazon and was received by his father - Mr. Elpidio Tuazon on May 11, 2023 (please see attached CSW on the case of Mr. Tuazon).

### Recommendations

To send a communication letter to Mr. Sarmiento reiterating all of the responses of the DENR is consistent that this Office already denied their requests pertaining to the areas of BPR.





- 2. In the 3rd quarter of 2022, the BPR Management Office conducted documentation on the claimed area of Mr. Tuazon; it was documented and observed that there are cottages made of a combination of light and concrete materials which was allegedly for tourism purposes;
- 3. Memoranda dated October 28, 2022, for the FMB Director thru the OIC, Forest Investment Development Division, and for the OIC, CENRO Calamianes Islands from the BPRMO Personnel regarding the request for assistance on the illegal occupation and illegal collection of fees within the BAI-NBCRDC area:

The report disclosed that the claimed area of Mr. Tuazon was also documented by the BPRMO personnel together with the investigation on other unlawful occupants within the area of jurisdiction of BAI-NBCRDC inside BPR. Based on the findings, Mr. Elbert Tuazon occupies a parcel of lot in So. Tulbuan, Brgy. Decalachao, Coron, Palawan within the BPR with an approximate area of 14,877 square meters or 1.4 hectares. House structure was documented on site and the area is already fenced.

4. Letter dated November 07, 2022, addressed to Mr. Elbert Tuazon, for information regarding the documentation and investigation of the BPR Management Office regarding their claimed area at the subject area;

The same letter was also sent to other identified alleged unlawful occupants namely: Mr. Stephen Vingno, Ms. Meriam L. Lagrosa, Mr. Darlito Maña, Mr. Rodrigo Molino, as well as to the Barangay Chairman- Hon. Franklin Usorfacion and the OIC-Chief, BAI-NBCRDC-Emily Espaldon-Victorio informing them on environmental laws, rules and regulations bounded to the BPR.

- 5. Communication letters dated March 17, 2023, regarding the invitation to the Clarificatory Technical Meeting, were addressed to Mr. Elbert Tuazon of So. Tulbuan, Brgy. Decalachao, Coron, Palawan within BPR; Hon. Franklin Usorfacion-Barangay Chairman of Brgy. Decalachao; and Emily Espaldon-Victorio, OIC, BAI-NBCRDC (for information);
- 6. On March 24, 2023, the BPR Management Office facilitated a Clarificatory Technical Meeting (CTM) at the 3rd Floor, BPRMO, CENRO Calamianes Islands, Brgy. Poblacion 5, Coron, Palawan regarding the unlawful occupation of Mr. Elbert Tuazon at So. Tulbuan, Brgy. Decalachao, Coron, Palawan within the area of BPR. Relative thereto, respectfully submitted is a draft report on the matter.
