

# BACKGROUND

On March 20, 2023, this office received a Memorandum dated March 07, 2023 from the Provincial Environment and Natural Resources Officer referring the memorandum dated February 22, 2023 of the OIC-ARD for Technical Services regarding the letter dated December 20, 2022 of Mr. Jesus S. Enila Jr. requesting for assistance relative to the above-cited subject.

In connection therewith, this Office has been instructed to conduct investigation in coordination with the concerned parties and submit report in CSW format.

- That on July 24, 2018, this Office received a letter from DMO II Ethel De Guzman, Office of Assistant Secretary for Field Operations-Luzon addressed to CENRO Conrado M. Corpuz referring the copy of the letter dated July 24, 2018 from Mr. Jesus S. Enila Jr., copy of the Memorandum dated August 11, 2018 from USEC Juan Miguel Cuna and Memorandum dated July 24, 2018 from ARD Tuddao;
- That on July 25, 2018, this Office received a Memorandum dated July 24, 2018 from the Assistant Regional Director for Technical Services referring the memorandum dated August 11, 2017 of the DENR Undersecretary regarding the letter dated August 3, 2017 from Mr. Jesus S. Enila, Jr. requesting assistance on Lot Nos. 719, 1541, 1542, 1536, 1537 and etc., all located at Bgy. Barong-Barong, Brooke's Point, Palawan to conduct an investigation and submit report;
- That on July 25, 2018, LMO III Florante A. Candido submitted a report duly received by this Office on the status of Lot Nos. 719, 1541, 1542, 1536, 1537 and recommended that Mr. Enila be advised to visit this Office to specify what assistance he expects and identify the 20 hectares he mentioned in his letter;
- That on July 30, 2018, this Office forwarded the copy of report submitted by LMO III Florante A. Candido dated July 25, 2018 to the Regional Director regarding the status of the lots subject of the request for assistance;
- That on July 30, 2018, this Office sent a letter to Mr. Jesus S. Enila Jr. informing him on the status of the lots he mentioned in his letter and inviting to visit this Office to specify what assistance he expects;
- That on September 10, 2018, this Office received a copy furnished of Memorandum from the PENRO Officer-in-Charge, Sonia M. Pascual addressed to the Regional Executive Director forwarding the CENRO Memorandum dated July 30, 2018 along with the investigation report of LMO III Florante A. Candido in compliance to the Office memorandum dated July 24, 2018 in relation to the request for assistance of Mr. Jesus S. Enila Jr.;
- That on September 18, 2018, this Office received an Acknowledgement Receipt from the DENR Central Office of the Memorandum dated July 30, 2018 re: Request for Assistance re: Lot Nos. 1543, 719, 1541, 1542, 1536, 1537, etc. Document Tracking No. (ASRMD-2017-0022227);
- That on November 19, 2018, this Office received a Memorandum dated November 12, 2018 from the OIC-Provincial Environment and Natural Resources Officer Felizardo B. Cayatoc referring the memorandum dated September 26, 2018 of the Regional Executive Director to follow-up the request for assistance of Mr. Jesus S. Enilar Jr. on lots 719, 1541, 1542, 1536 and 1537 with attached copy of lot data computation;

- That on November 21, 2018, this Office forwarded a Memorandum to the Regional Executive Director with attached copies of the actions taken of this Office in compliance with the instructions contained in the Regional Memorandum dated July 24, 2018;
- That on December 14, 2018, this Office received a copy furnished of Memorandum dated December 04, 2018 from the PENR Officer Felizardo B. Cayatoc addressed to the Regional Director forwarding the CENRO Memorandum dated November 21, 2018 along with the investigation report of LMO III Florante A. Candido in compliance to the Office Memorandum dated July 24, 2018 in relation to the request for assistance of Mr. Jesus S. Enila Jr.;
- That on December 02, 2022, this Office received a copy of Memorandum dated November 25, 2022 from the OIC, Assistant Regional Director addressed to the PENR Officer attention to CENR Officer Conrado M. Corpuz referring the memorandum dated October 13, 2022 of the Undersecretary for Field Operations-Luzon, Visayas and Environment with a subject: Letter dated August 02, 2022 of Mr. Jesus S. Enila, Jr. requesting for assistance re: issues on untitled Lot Nos. 201 and 719 located in Brooke's Point, Palawan;
- That on December 05, 2022, this Office sent a letter to Mr. Jesus S. Enila Jr. informing him on the status of Lot No. 201, PLS-96 and Lot No. 719, PLS-96 and requesting to visit this Office to schedule an ocular inspection on the lots he requested for assistance;
- That on December 05, 2022, this Office forwarded a Memorandum to the Regional Executive Director attention to the OIC, Assistant Regional Director copy furnished to the Presidential Complaint Center, Office of the President and the Undersecretary, Field Operations acknowledging the memorandum dated November 05, 2022 and informing on the status of Lot Nos. 201 and 719. Further, suggesting that Mr. Jesus S. Enila Jr. be advised to visit this Office for an schedule of ocular inspection on the ground to ascertain the specific lot numbers being requested for assistance;
- That on January 06, 2023, this Office received a copy furnished of Memorandum dated December 19, 2022 from the PENRO Officer-in-Charge, Rhodora B. Ubani addressed to the Regional Executive Director forwarding the CENRO Memorandum dated December 05, 2022 informing the status of Lot No. 201, PLS-96 and Lot No. 719, PLS-96 per records verification;
- That on January 24, 2023, this Office received an email dated January 23, 2023 from the PENR Officer Felizardo B. Cayatoc referring the 8888 Citizen's Complaint of Mr. Jesus S. Enila Jr. re: follow-up on Ticket Reference No. SMS-G-20221112-280-18;
- That on January 25, 2023, this Office sent a letter to Mr. Jesus S. Enila Jr. copy furnished to the Presidential Complaint Center, Office of the President, the Regional Executive Director and the PENRO Officer informing of the actions taken by this Office on his previous letters and inviting him to visit this Office to specify what assistance he expects;
- That on February 02, 2023, this Office received a Memorandum dated January 24, 2023 from the PENR Officer Felizardo B. Cayatoc instructing to coordinate with Mr. Jesus S. Enila Jr. and submit report on actions taken of this Office in relation to Reference Code No. with code no. SMS-G-20221112-280-18, G20221124-391-1, G20221219-62-5 and G20221124-391-1 re: complaint of Mr. Jesus S. Enila Jr. re: Land Dispute in Barangay Barong-Barong, Brooke's Point, Palawan;

That on even date, this Office received a copy furnished of Memorandum dated January 30, 2023 from the PENR Officer Felizardo B. Cayatoc addressed to the DENR Action Center/ Hotline furnishing the memorandum to Regional Executive Director dated December 05, 2022 and letters to Mr. Jesus S. Enila Jr. dated December 05, 2022 and

January 25, 2023. Further, informing that as per letter replies this Office is inviting Mr. Jesus Enila Jr. to visit the CENRO Brooke's Point Office for the schedule of ocular inspection to ascertain the specific lot numbers located in the different barangays of Brooke's Point and to address his official concerns pertaining to the complaint;

That on March 20, 2023, this Office received a Memorandum dated March 07, 2023 from the PENR Officer Felizardo B. Cayatoc referring the memorandum dated February 22, 2023 of the OIC-Assistant Regional Director instructing this Office to conduct investigation on Lot Nos. 201, 719, 1536, 1537, 1541, 1542, 1544 and 1545 and submit report in CSW format.

## **OCULAR INSPECTION**

- a. That on March 24, 2023, CENRO Leonard T. Caluya gave an instruction to conduct an investigation and submit report in CSW format pertaining to the request for assistance of Mr. Jesus S. Enila Jr. on Lot Nos. 201, 719, 1536, 1537, 1541, 1542, 1543, 1544 and 1545, all PLS-96 located at Bgy. Barong-Barong, Brooke's Point, Palawan;
- b. That on March 29, 2023, the "team" composed of LMI Edelyn A. Evangelista and LMI Renan Kenneth M. Fuentes left this Office and proceeded to Bgy. Barong-Barong, Brooke's Point, Palawan. Upon arrival, the team paid courtesy call to the on-duty Barangay Official and signed on their logbooks. After that, the team went to the house of Yolanda E. Paraiso- sister of Mr. Jesus S. Enila Jr. to informed her regarding on the instruction from the Regional Office to conduct an ocular investigation on the lots requested for assistance by Mr. Jesus S. Enila Jr. since that Mr. Enila Jr. is in Mindanao. She informed us that she has no idea on the lots claimed by his brother even her mother. She added, that she advised her brother to come home so that he can explain his claims over the above-mentioned subject lots. Also, based on the interview with Mrs. Yolanda S. Paraiso, she told us that Mr. Jesus S. Enila maybe has a mental problem because as she remembered even their old house was demolished by his brother as he claimed that there is a buried "gold bar" in that place;
- c. The team also conducted inspection and interview with the owner/claimants of the abovementioned subject lots, it was found and observed the following:
  - That Lot No. 201, PLS-96 containing an area of 1,166 square meters is located at Bgy. Mainit, Brooke's Point, Palawan. It is occupied by the Barangay LGU of Mainit, Brooke's Point, Palawan since 1976 up to present and several structures built within the lot such as Barangay Hall of Mainit, Barangay Birthing Home and Barangay Center;
  - That Lot No. 719, PLS-96 identical to Lot No. 869, Cad 796-D containing an area of 83,766 square meters is located at Bgy. Amas, Brooke's Point, Palawan. It is covered by HA 2-1191 of Juan Feliciano patented on February 16, 1977 under Patent No. 130028. That the area is cultivated as a corn field and planted with several kind of trees;
  - 3. That Lot No. 1536, PLS-96 identical to Lot No. 5154, Cad 796-D containing an area of 1,200 square meters is located at Barangay Barong-Barong, Brooke's Point, Palawan. It is covered by FPA (IV-29)02691 of Lilia Paulino patented on September 30,1988 under Patent No. 02961. That the whole area is enclosed with fence made of barbed wire and planted with 6 coconut trees aged 30 years old;

- 4. That Lot No. 1537, PLS-96 identical to Lot No. 5155, Cad 796-D containing an area of 1,200 square meters is located at Barangay Barong-Barong, Brooke's Point, Palawan. It is covered by MSA- V-64254 of Numeriano San Juan. That Mr. Numeriano San Juan sold the area in favor of Mrs. Sebido and built with a concrete house enclosed with fence made of barbed wire;
- 5. That Lot No. 1541, PLS-96 identical to Lot No. 5159, Cad 796-D containing an area of 1,200 square meters is located at Bgy. Barong-Barong, Brooke's Point Palawan. It is covered by FPA 045306-10-28658 of Lilia S. Bitago patented on November 19, 2010 under FP 045306-10-28658. More or less four (400) hundred square meters portion of the area was sold to Raquel F. Antolino built with a concrete house and the remaining eight (800) hundred square meters portion is occupied by Lilia S. Bitago built with a concrete house therein;
- 6. That Lot No.1542, PLS-96 identical to Lot No. 5160, Cad 796-D containing an area of 898 square meters is located at Bgy. Barong-Barong, Brooke's Poitn, Palawan. It is covered by FPA 045306-12-3058 of Norberto M. Bitago patented on April 11, 2012 under FP 045306-12-3058. That the area is planted with gmelina trees, coconut trees, banana, bamboo "tiring" and nipa palm;
- 7. That Lot No. 1543, PLS-96 identical to Lot No. 5161, Cad 796-D containing an area of 898 square meters is located at Bgy. Barong-Barong, Brooke's Point, Palawan. It is covered by FPA 045306-1013 of Segundina Enila patented on December 20, 2005 under FP 045306-05-18661. That the northeast portion of the area is occupied by Jesus S. Enila Jr. built with a concrete house and the eastern portion of the area is peacefully occupied by Yolanda E. Paraiso built with house made of light materials. Also, the eastern portion of the area is partly planted with several trees such as: 100 coconut trees aged 30 years old, santol trees, gmelina trees and nipa palm;
- 8. That Lot No. 1544, PLS-96 identical to Lot No. 5162, Cad 796-D containing an area of 1,200 square meters is located at Barangay Barong-Barong, Brooke's Point, Palawan. It is covered by MSA (III-7)651 of Prudencio Briones and FPA Unnumbered of Lilia S. Bitago. That the area is being occupied and cultivated by Lilia S. Bitago planted with gmelina trees, banana, bamboo "tiring" and 30 coconut trees aged 30 years old;
- 9. That Lot No. 1545, PLS-96 identical to Lot No. 5163, Cad 796-D containing an area of 1,200 square meters is located at Barangay Barong-Barong, Brooke's Point, Palawan. It is covered by FPA 045306-1445 of Florita O. Bonawas patented on October 02, 2008 under FP 045306-08-23933. That the north portion of the area is occupied by Florita O. Bonawas built with semi-concrete house; the northwest portion of the area is occupied by Rinny Bonawas built with semi-concrete house; the western portion of the area is occupied by Albec Bonawas built with concrete house; the southwest portion of the area is occupied by Jubeto Bonawas built with concrete house; and the southern portion of the area is occupied by Fernando Bonawas built with house made of light materials;

d. At 5:00 PM the inspection was concluded and the team left the area. Please see attached copy of geo-tagged photos taken hereto attached;

### **OBSERVATION, FINDINGS AND COMMENTS:**

- a. As per letter of Mr. Jesus S. Enila Jr. dated December 20, 2022, he mentioned that Lot No. 1543, PLS-96 was titled in the name of her mother- Segundina Enila where their family home was erected and allegedly applied by another person, however based on records on file of this Office that Lot No. 1543, PLS-96 is patented to Segundina Enila on December 20, 2005 and on the ground, it was found that Lot No. 1543, PLS-96 is presently occupied by Mr. Jesus S. Enila Jr. built with a concrete house on the northeast portion and the eastern portion of the area is occupied by his sister named Yolanda E. Paraiso built with house made of light materials. Also, the eastern portion of the area is partly planted with several trees such as 100 coconut trees aged 30 years old, santol trees, gmelina trees and nipa palm.
- b. As per letter of Mr. Jesus S. Enila Jr. dated December 20, 2022, he mentioned that Lot No. 201, PLS-96 is located at Barangay Barong-Barong, Brooke's Point, Palawan wherein on the ground it is located at Barangay Mainit, Brooke's Point Palawan approximately six (6) kilometers away from Barangay Barong-Barong.
- c. As per letter of Mr. Jesus S. Enila Jr. dated December 20, 2022, he mentioned that Lot No. 719, PLS-96 is located at Barangay Barong-Barong, Brooke's Point, Palawan wherein on the ground it is located at Barangay Amas, Brooke's Point Palawan approximately sixteen (16) kilometers away from Barangay Barong-Barong.
- d. That upon verification on records on file of this Office and ocular inspection conducted by the team, Lot No. 719, PLS-96 is patented to Juan Feliciano; Lot No. 1536, PLS-96 is patented to Lilia Paulino; Lot No. 1541, PLS-96 is patented to Lilia S. Bitago; Lot No. 1542, PLS-96 is patented to Norberto M. Bitago; Lot No. 1543, PLS-96 is patented to Segundina Enila; and Lot No. 1545, PLS-96 is patented to Florita O. Bonawas while Lot No. 201, 1537, 1544, all PLS-96 were not yet patented but occupied by Barangay LGU of Mainit, Mrs. Sebido and Lilia Bitago respectively;
- e. That at present, there is no record on file showing Mr. Jesus S. Enila Jr. has filed any public land application for lot/s within the administrative jurisdiction of this Office.
- f. That the other issue/topic he mentioned in his letter and text received from Mr. Jesus S. Enila Jr. is not related on the above- mentioned subject, please see copy of screenshot of text received from Mr. Jesus S. Enila Jr. hereto attached.
- g. That the Lot Nos. 1536, 1537, 1541, 1542, 1543, 1544, 1545, all PLS-96 are within Alienable and Disposable Zone under Land Classification Map No. 884, Block II, Project No. 12-A, duly certified by Bureau of Forestry on April 30, 1931;
- h. That Lot No. 201, PLS-96 is within Alienable and Disposable Zone under Land Classification Map No. 1455, Block I, Project No. 12-D, F.A.O # 4-601, duly certified by Bureau of Forestry on July 18, 1941;
- That Lot No. 719, PLS-96 is within Alienable and Disposable Zone under Land Classification Map No. 884, Block II, Project No. 12-A, duly certified by Bureau of Forestry on April 30, 1931;

# RECOMMENDATION

It is respectfully recommended that Mr. Jesus S.
