Respectfully forwarded is the letter dated June 13, 2023 of Rio Tuba Nickel Mining Corporation (RTNMC) Resident Mine Manager Ronelbert A. Suguitan together with the Aquatic Resource Assessment report for CY 2022 in compliance with the terms and conditions of their Environmental Compliance Certificate (ECC-CO-1312-0043) under No. 7 stating that "The proponent shall continue to monitor the aquatic biota of all surface water resources in the area."

The aforementioned report contains data and information on the result of a recent assessment of the condition of aquatic biota of all surface water resources in the area located in Barangays Rio Ruba and Ocayan, Bataraza, Palawan. The study reveals that the primary physicochemical parameters (pH and DO) of the freshwater bodies are within the acceptable range prescribed under DAO 2016-08 or the Water Quality Guidelines and General Effluent Standard of 2016, for Class A, B, and C water bodies. Aside from this, all water quality parameters in the marine areas are within the standards of Class SC water bodies, suitable for the propagation and growth of fish and other aquatic resources.

Further, this office commends the initiative of the mining company in conducting regular monitoring of water quality parameters in the upland and marine waters to ensure the quality of water is properly maintained.
