

I am writing your good office in connection with our requested appointment with Executive Secretary Lucas P. Bersamin to discuss the *BuCor Development Plan Road Map on addressing the congestion problems in correctional facilities.* 

As part of my talking points, I will discuss the following:

- 1. On realization of Regionalization and Establishment of Heinous Crimes Facility within Military Reservations pursuant to RA 10575 and RA 11928.
- 1.1 Updates on the repurposing of areas and/or facilities in Fort Magsaysay, Military Reservation in Nueva Ecija, including the progress in the other two military reservations in Visayas (Camp Macario B Peralta Jr, Jamindan, Capiz) and Mindanao (Camp Kibaritan, Kalilangan, Bukidnon). See related Documents as TAB
  "A"
- 1.2 Land swapping (within prison reservations in Palawan and Leyte) to compensate DND-AFP for the parcels of land repurposed or allocated to BuCor for the regionalization/establishment of Heinous Crimes Facilities See related documents as TAB "B"
  - 1.3 Ongoing thrust to identify available islands for establishment of Heinous Crimes Facilities. Letter addressed to Director of Biodiversity Management Bureau of DENR marked as **TAB** "C"

- 2. On the Decongestion, Transfer and Development of New Bilibid Prison in Muntinlupa City.
  - 2.1 Full implementation of RA 10592 or the New GCTA PDL and indorsement for other forms of executive clemency to all qualified PDL.
  - 2.2 Hasten the completion of 1Billion infrastructure projects in Davao Prison and Penal Farm, Iwahig Prison and Penal Farm and Leyte Regional Prison to effect the transfer of almost 10,000 PDL.
  - 2.3 Pursue the development of NBP as Muntinlupa Global City through PPP modality pursuant to RA 6957 as amended by RA 7718. See Attached PPP Concepts and Process for BuCor marked as TAB "D".
- 3. On the acquisition of additional land for regional facilities
  - 3.1 Pursue the pledges of several politicians (Gov, Albano of Isabela, Gov. Mamba of Cagayan, Cong. Villafuerte of Camarines Sur, Mayor Reliquias Hinoba-an, Negros Occidental, and Mayor Ecleo of Dinagat Island) and philanthropies (Atty. Moya donating 10has of real property in Bago City, Negros, Occidental). See attached Program of Activities as TAB "E"
  - 3.2 Continue coordination with Regional Development Council of CAR, CARAGA and Bicol Region for establishment of Regional Prison Facilities. See item No.3 of TAB "E"
  - 3.3 Recovery of previously BuCor owned land ceded to LGU of Mindoro, Palawan, Davao Del Norte and Zamboanga which remains idle and undeveloped to this date on the basis of Rule VI, Sec 6 (a)(1) and Rule XXI, Section 26 of the revised IRR of RA 10575.
