This is to provide a status on the discussion of the Department of Environment and Natural Resources (DENR) - National Commission on Indigenous Peoples (NCIP) on the <u>Subgroup on FPIC, Tenurial Instruments and other DENR permits, and Enforcement</u> which is being cochaired by Engr. Caridad Katherine Gullunan from the NCIP. Be informed that this subgroup conducted its third meeting last 28 April 2023, attended by representatives from NCIP, DENR field offices, LMB and FMB and discussed the updates of the agreements during the second meeting. From the last meeting conducted last 14 March, the group revisited the commitments of the NCIP and DENR which include(s) the following:

#### TOPIC

### **STATUS**

- NCIP to discuss and present their proposed level of participation on DENR activities especially on the processes of issuance of Cease and Desist Orders (CDO) and other administrative process
- Not yet discussed
- NCIP to provide access to the existing IPO registry and other similar databases relevant to tenure/permit issuances;
- NCIP submitted their inputs last April 2023
- NCIP to provide a directory/database of NCIP officials/staff/indigenous peoples organizations representatives to assist the forest tenure instrument applicants on the FPIC process;
- NCIP submitted their inputs last April 2023
- 4. DENR to submit the list of programs and permits being issued
- This was already included in the last briefer and was updated based on the inputs of LMB.
- DENR to submit draft MOA to NCIP for review and comments
- Already being discussed with the Subgroup being handled by LAS

Aside from this, the group also discussed the inputs/comments from the DENR Regional Offices and requested Regions 1 and 10 to present their initiatives, to wit:

- Forging of Memorandum of Understanding and Joint Operational Agreements % Region 1 and 10
- Mapshop or the The Map Considalition of the DENR, NCIP, DAR and AFP % Region 10
  - In a Memorandum dated 12 April 2023, the Bureau also requested our Regional Offices to prepare shapefiles that will be used in the Mapshop. This Office already received submissions from Regions 3, 5, 6, 9, 10, 11, 13 and CAR

The summary of the discussion and agreements is attached as Annex including the proposed Memorandum of instruction for the Regional Offices to initiate the conduct of a regional mapshop together with the NCIP, DAR, AFP, and NEDA during their Regional Development Council meeting for the harmonization of data and policies.
