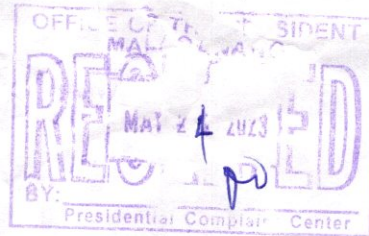



## **NOTICE TO VACATE**

**MR. ELBERT TUAZON**  
So. Tulbuan, Brgy. Decalachao  
Coron, Palawan

Dear **MR. TUAZON**

This is to notify you that the Busuanga Pasture Reserve (BPR), formerly Yulo King Ranch (YKR), proclaimed under Presidential Proclamation No. 1387 in 1975, has been withdrawn from sale, any form of disposition, exploration or exploitation and reserved same as a Pasture Reserve which until now is in full force and effect. Further, the administration of the BPR was transferred from Philippine Forest Corporation (PFC) to Forest Management Bureau (FMB) of the DENR pursuant to the Presidential Proclamation No. 663 (attached herewith).

Based on the investigation conducted on October 6, 2022 by the BPR Management Office and on the documents available in this office, you have no substantial documents to prove that you are entitled to occupy/possess a part of the area within the BPR.

By reason, thereof, you are hereby directed to **REMOVE THE STRUCTURE/S** you built and **VACATE THE AREA** you are occupying in violation of **Presidential Proclamation No. 1387 and Presidential Decree No. 705**, as amended, otherwise known as the *Revised Forestry Code of the Philippines*:

Section 20. No person may utilize, exploit, occupy, possess or conduct any activity within any forest or grazing land xxx, unless he had been authorized to do under a license agreement, license, lease or permit xxx;

**Section 78.** Any person who enters and occupies or possess xxx any forestland or grazing land or part thereof xxx or refuses to vacate the area when ordered to do so, pursuant to the provisions of Section 53 hereof;

In view hereof, you are hereby forewarned and this Office is giving you **FIFTEEN (15) DAYS** upon receipt of this Notice to voluntarily remove, dismantle any structures constructed/ installed therein, and vacate the area; otherwise, we will be compelled to take legal actions and file a case/s against you before the proper court for violation.

We are hoping you will give this matter your preferential and utmost attention in order to avoid a costly litigation.
