Dear Madam and Sirs,

We, the undersigned representatives of the coalition BANTAY KALIKASAN NG SIBUYAN, write to follow-up the status of our letter-complaints dated 17 January 2023 and 30 January 2023 wherein we respectively raised issues and concerns surrounding Altai Mining's licensing and permits for its mining operations in San Fernando, Romblon and the Irregularities and anomalies surrounding Altai Mining's Ore Transport Permit (OTP) and Mineral Ore Export Permit (MOEP) involving an excessive 50,000 WMT of nickel lateritic ore.

We are aware that your respective offices have issued several notices of violations, including the Joint Order dated 06 February 2023, in seeming response to our letters which brought attention to your offices the illegal and destructive activities of Altai Mining in Sibuyan Island. Said order required, among others, the filing of appropriate legal actions for tree-cutting without a permit and the conduct of investigation on the potential damage to the marine areas of the company's illegally constructed port/wharf.²

We understand that the said Joint Order is immediately executory upon receipt.

We write once again to your offices to follow-up on the status the investigation and the cases that were intended to be filed in accordance with Items No. 5 and 6 thereof. As of this writing, there still seems to have been no full-fledged investigation nor the filing of any appropriate legal action initiated by the PENRO Rombion against Altai Mining's illegal and destructive activities.

Having brought attention to your offices this matter in our January 2023 letters, we are further requesting that if such investigation or legal action is initiated, BANTAY KALIKASAN NG SIBUYAN, should be an integral part of the said activities for the sake of transparency and neutrality on the part of the investigating body.








We, the undersigned representatives of the coalition **BANTAY KALIKASAN NG SIBUYAN**, write to follow-up the status of our letter-complaint dated 30 January 2023 where we raised issues and concerns surrounding Altai Mining's illegal construction and operation of its port in in Brgy. España, San Fernando, Romblon.

We are aware that your office has issued a notice of explanation dated 03 February 2023 to Altai Mining for them to explain their acts of constructing a port on Sibuyan Island in Romblon without the necessary permit. We also understand that Altai Mining was ordered to respond to the said notice within five (5) days from its receipt thereof.

We write once again to your office to follow-up on the status of the investigation and if there are any cases intended to be filed regarding Altai Mining's illegal construction and operation of its port. As of this writing, there still seems to have been no meaningful update or response from your office as to the developments of the investigation.

Having brought attention to your office this matter in out January 30 letter, we are further requesting that if an investigation or legal action is initiated, or if such are already being conducted, BANTAY KALIKASAN NG SIBUYAN should be an integral part of the said activities for the sake of transparency and neutrality on the part of the investigating body.

Lastly, may we also inquire if there is any investigation that is ongoing on Altai Mining's illegal construction and operation of its port, as contained in our January 30 letter?

Your immediate action and response on the contents of this letter in accordance with ARTA will be most appreciated.
