Please be guided by the following provisions of DAO No. 2007-29, the "Revised Regulations on Land Surveys", which states that, among others:

Sec. 9 Persons Authorized to Conduct Land Surveys

(a) "He/she shall be a holder of a valid Professional Regulation Commission (PRC) registration, PRC identification card" xxx

(b) xxx

Sec. 74 Denial of Approval

"Violation of any provisions of this Regulation by the Geodetic Engineer and survey contractor shall be sufficient grounds for the RTD for Lands to deny acceptance for verifications and/or approval of any survey made by him" xxxx

In view hereof, you are advised not to accept any survey returns submitted by Engr. Muñoz, unless he could submit proof of renewal of his PRC Registration and PRC Identification Card.

Dear Engr. Tambo,

This is to acknowledge receipt of your Letter dated May 5, 2023 requesting this Office not to accept survey returns submitted by Engr. Isabelo Ubando Muñoz and to stop relevant transactions bearing his name and signature.

Based on the documents, Engr. Isabelo Ubando Muñoz, a member of the Geodetic Engineers of the Philippines-National Capital Region (GEP-NCR), is a registered Geodetic Engineer with License No. 0002603 issued on August 21, 1967.

However, upon verification with the Professional Regulation Commission (PRC) Licensure and Registration Division, it was found out that Engr. Muñoz is practicing the profession with an expired license through a certification dated January 17, 2023, signed by Mr. Gary R. Jose, Senior Professional Regulation Officer of PRC-NCR which states that the alleged PRC ID No. 0002603 with expiry date of July 08, 2024 was not issued by the said office.

We emphasize the provisions of DAO No. 2007-29, the "Revised Regulations on Land Surveys" which states, among others:

Sec. 9 Persons Authorized to Conduct Land Surveys

(a) "He/she shall be a holder of a valid Professional Regulation Commission (PRC) registration, PRC identification card" xxx

(b) xxx

Sec. 74 Denial of Approval

"Violation of any provisions of this Regulation by the Geodetic Engineer and survey contractor shall be sufficient grounds for the RTD for Lands to deny acceptance for verifications and/or approval of any survey made by him" xxxx We highly appreciate your action in calling our attention on this matter. Hence, we deem it best to inform all the Regional Office to stop dealing / transacting with Engr. Muñoz.

Dear Director Talabis,

Greetings from the Geodetic Engineers of the Philippines - National Capital Region!

We are writing to your office to inform you that we have started an inquiry into one of our members and have found that he is practicing and submitting plans at DENR without a valid renewed PRC license. We have secured a certification from the Professional Regulations Commission (PRC) that his PRC ID has not been released pending his submission of the Certificate of Good Standing (CGS).

We have already informed the DENR-NCR, DENR-Calabarzon, DENR-Region 3 and also the Land Registration Authority (LRA) and have requested that plans bearing his name and signature not be accepted. The DENR-NCR and LRA have already informed us that they will no longer accept his plans.

We have attached the following for your reference:

- 1. PRC Certification
- 2. GEP-NCR Letter to DENR-NCR
- 3. GEP-NCR Letter to LRA
- 4. Reply Letter of DENR-NCR to GEP-NCR
- 5. Reply Letter of LRA to GEP-NCR

Further, we have also received several complaints relative to the surveys submitted by Engr. Munoz, alleging irregularities, misinterpretations and problems with his services. Engr. Munoz has also claimed that his signatures were forged in some of the plans submitted to DENR.

With this information that he does not have a valid PRC ID issued to him, we hope that your office could also stop relevant transactions bearing his name and signature. This will prevent further problems and will help clients to avail the services of a licensed Geodetic Engineer.

We hope that this merits your favorable action.

This is in connection to your letter dated February 21, 2023 addressed to the Honorable Administrator, this Authority, requesting on the non-acceptance and non-approval of survey returns submitted by Engr. Isabelo Ubando Muñoz, in this Authority.

Please be informed that Engr. Muñoz visited my office regarding the subject-matter last February 20, 2023 at 8,00 in the morning relative to your previous letter dated January 24, 2023 which was referred to our office by Atty. Tristan E. De Guzman Director Administrative Service last January 26, 2023, for appropriate action. Engr. Muñoz reasoned with the undersigned that "Paano ko mahabayaran ang Association (GEPI) kung ipapatigil nila ang pag entry at pag approve ng aking mga plano" and we have already come to an agreement that this Authority shall accept and process the entry and approval of the survey plans submitted by Engr. Muñoz for a period of three (3) months starting. February 20, 2023, hence, a Memorandum dated February 20, 2023 was prepared for reference of the Subdivision and Consolidation Division (SCD), this Authority.

With regards to your request on the non-acceptance/non-approval of the survey plans of Engr. Muñoz, this Office has no authority to bar without an Order issued by the Professional Regulation Commission (PRC), that's why Engr. Muñoz was given a three (3) month period to settle his monthly or yearly dues to the association in order for him to secure the required Certificate of Good Standing for the renewal of his PRC ID.

However, rest assured, in the event that he will not show any proof that he has settled his obligations on the payment due to the association, within the three (3) month period as agreed upon, we will no longer accept any survey returns from him.
