SUBJECT : SITUATIONAL REPORT ON THE INCIDENT OF MOTOR

TANKER SUBMERGED IN BALIWANGAN POINT WITHIN THE JURISDICTION OF NAUJAN, ORIENTAL MINDORO

Relative to the above subject, please be informed that the incident is within the administrative waters of the Municipality of Naujan, Oriental Mindoro on February 28, 2023 where a half-submerged Motor Tanker run aground due to heavy winds.

According to the information from other government agencies, the Motor Tanker were already submerged and diesel fuel from the engine were already leaking with a range of six (6) kilometers long and four (4) kilometers wide. Accordingly, some Marine Protected Areas (MPAs) within the Municipality of Naujan were already affected. The Philippine Coast Guard, Calapan City confirms that installation of spill booms was not yet initiated due to gale warning in the area and the exact location of the Motor Tanker cannot be determined. However, the Marine Environmental Protection Force (MEPFo) of the Philippine Coast Guard were already deployed to conduct water sampling and other investigatory activities. Aerial documentation were already conducted by the PCG to determine the extent of fuel spill as well as giving notices to all mariners and fishermen to avoid such area. The PCG will continue to informed about the latest update on the incident.

The PENRO Monitoring and Enforcement personnel had coordinated with the LGU concerns and accordingly, no presence of fuel oil within the shorelines of Barangays San Antonio, Estrella, Herrera, and San Jose, Naujan, Oriental Mindoro.


Another incident of aground marine vessel is identified as MV Oceana Uno, allegedly, originated from Manila carrying stone boulders to be transported to the Province of Palawan. Due to heavy weather in the area, the said Motor Vessel drifted within the shoreline of Brgy. San Antonio, Naujan. No oil spill has been observed and no damages on mangrove areas. Further investigation will be conducted to determine if there were areas of sea grasses affected by the said incident.




