**SUBJECT: DESIGNATION OF POLLUTION CONTROL OFFICERS (PCOs) OF
DENR - PENRO MARINDUQUE**

In the interest of the service and in order to effectively enforce RA 9275, otherwise known as Philippine Clean Water Act of 2004, in consonance with DENR Administrative Order No. 2014-02, *Revised Guidelines for PCO Accreditation* and to carry-out the national policy of maintaining a good quality of the environment, the following personnel are designated as Pollution Control Officers, namely:
