The Senate Committee on Environment, Natura Change invites the Department to its public hearing on Tuesday, March 14, 2023, 10:00 a.m. at the Senator Geronima T. Pecson Room, Philippines, J.W. Diokno Boulevard, Pasay City to discuss the recent oil spill incident in Oriental Mindoro that is causing surmounting damages and biodiversity in the area as contained in the following:

- Proposed Senate Resolution No. 537 Resolution Directing the Senate Committee on Environment, Natural Resources and Climate Change to Conduct an Inquiry, in Aid of Legislation, on the Escalating Oil Spill from the Sunken Tanker MT Princess Empress that is Causing Surmounting Damages to the Marine Ecosystem and Biodiversity, Among (Introduced by Senator Cynthia A. Villar); and
- Privilege Speech of Senator Francis "Tol" N. Tolentino, entitled: "Mindoro Oil Spill Incident" delivered during the March 6, 2023 plenary session.

The Committee also requests a copy of the aforementioned incident and the actions taken by DENR on the matter, as well as pertinent documents relative thereto.

In this regard, as recommended by the Secretary, may we invite you to attend as resource persons to the public hearing.
