I am the owner of that beachfront property in Sitio Dolarog denominated as Cadastral Lot No. 737, Cad. 1037-D, C-4, covered by Tax Declaration No. 13-008-0928 with Property Identification No. 066-13-008-12-026.

I just received a report that a squatter or squatters are trespassing and erecting a structure or structures on the hilly rear portion of my property. As you know, in protected areas such as El Nido, no occupation, usurpation or construction should take place without proper authority.
