Greetings to you sir/madam,

Last March 7, 2023 I went to CENRO Roxas, Palawan, there I met/talked/discussed with a lady CENRO staff who told me that she will help me/ assist me to VERIFY THE STATUS CLASSIFICATION OF LOT NUMBER 4921 where my two (2) sons Sandy Clavel Enolpe and Keneeth Clavel Enolpe have acquired portions of the area from depunto Raymond Sabillo Marion for just 2,000 sq. meters more or less respectively. Upto this writing I get nothing from her.

## Attached are the following:

- 1) Copy of cadastral survey card of lot number 4921 under Rogelio Marañon. After his death the remaining land area of lot 4921 was divided by his heirs:
- Sketch plan for Ramises Sabillo Marañon with an area of 23,000 plus sq. meters covered by Tax Declaration No. 18-21-008-2737
- 3) Sketch plan for Raymond Sabillo Marañon with an area of 24,000 sq. meters plus covered by Tax Declaration No. 21-008-2572. Before he died last November 2018, my two sons were able to acquired portion of lot from depunto Raymond's share of lot no.4921 as per sketch plan signed by Raymond S. Marañon:
- 3a). Sketch plan for Sandy Clavel Enolpe for 2,000 sq. meters more or less duly signed by Raymond S. Marañon. Nabakuran na po ito since 2018.
- 3b) Sketch plan for Keneeth Clavel Enolpe for a total of 600 sq. meters more or less (500 sq. m..more or less with sketch plan duly signed by Raymond S. Marañon but the additional 100 sq. meters has No sketch plan because Raymond was waiting for the cenro from roxas to come to port barton to do gps survey and prepare the sketch plan but unfortunately Raymond died before it was done. Nabakuran na din po ito since 2018.
  - Also attached is an screenshot of "<u>Tax Map A&D</u>" of the area.

As parent of my two sons, we built a house and lived in the area since 2018 and I take this opportunity to verify from your good office the actual/present status of land classification as we are just a walking distance where the orange pipe is.
