Transformative Actions for Climate and Ecological Protection and Development

Background:

The TRANSCEND project is the outcome of the International Climate Initiative (IKI) Country Call in 2018 that was based on the Philippine government's submission of concept, which aims at supporting the Philippine Government in achieving the NDC and post-2020 Biodiversity Framework targets.

The project intends to work with the Philippines on the four IKI funding areas, namely mitigating greenhouse gas emissions, adapting to climate change impacts, conserving natural carbon sinks, and conserving biodiversity. The project will also address integrating gender-responsive and gender-transformative approaches as means to accommodate context-specific gender relations. TRANSCEND will be implemented by a consortium of different organizations as shown in the table below:

To fully achieve the intended outcomes of the project, TRANSCEND takes on an integrated landscape management approach to project conceptualization and implementation. The project has identified the following considerations for selecting the focus landscapes in the country:

- 1. Geographic Distribution of Impact
- 2. Natural Capital
- 3. Relevance to National Government Priorities
- 4. Connectivity of Results and Impacts

Given these considerations, TRANSCEND has proposed the following landscapes for its implementation:

- Luzon Landscape: Verde Island Passage (VIP) Batangas, Oriental Mindoro, Marinduque, Romblon
- Visayas Landscape: Iloilo-Panay-Concepcion River Basin (IPCRB) Capiz, Iloilo, Aklan
- Mindanao Landscape: Metro Cagayan de Oro Misamis Oriental, Camiguin, Bukidnon

Objectives:

The workshop aims to discuss the TRANSCEND project with the stakeholders in the sub-national level (regional, provincial, and municipal/city) and to gather inputs for the current outcome, outputs, and indicators of TRANSCEND.

Moreover, the workshop specifically aims to:

- Present and discuss the provisional implementation plan for the TRANSCEND project including outcomes, outputs, and indicators.
- Gain a good understanding of the gaps and challenges in the sub-national levels.
- Determine the current initiatives of the local governments for climate change adaptation and mitigation and biodiversity.
