Please be informed that the Forest Management Bureau shall conduct an Online Orientation cum Stakeholders Consultation on Costings of the Phases of Plantation Development and Financial Requirements in support of the Financial/Credit Assistance Programs in Forestry Investment on 31 March 2023 via Zoom Videoconferencing.

This activity shall determine the information/data of tenure holders (e.g. asset size, production cost) from the DENR Field Offices which are required by the Development Bank of the Philippines (DBP) and the Land Bank of the Philippines (LBP) to acquire the available programs that will provide financial/credit assistance to the tenure holders. Said assistance can support the various eligible projects such as plantation development, acquisition of equipment and pieces of machinery, enterprise/livelihood development, etc. Moreover, the activity is vital in planning the way forward activities and possible policy amendments of the financial/ credit assistance programs in forestry investment in the future.
