Please be informed that on March 7, 2023 the National Commission on Indigenous Peoples (NCIP) Palawan Provincial Office conducted Information Education Campaign (IEC) for the delineation of ancestral domain and for the issuance of Certificate of Ancestral Domain Title (CADT) of Calamian Tagbanua ICC's in Barangay Bulalacao, Coron, Palawan.


During the IEC Ms. Mary Ann L. Delos Santos, CDO III/PDT Staff discussed the petition for delineation and recognition of ancestral domain and for the issuance of Certificate of Ancestral Domain Title (CADT) of Indigenous peoples of Barangay Bulalacao, Coron, Palawan. Ms. Delos Santos also discussed the salient features of Indigenous Peoples' Rights of 1997 (Republic Act no. 8371).

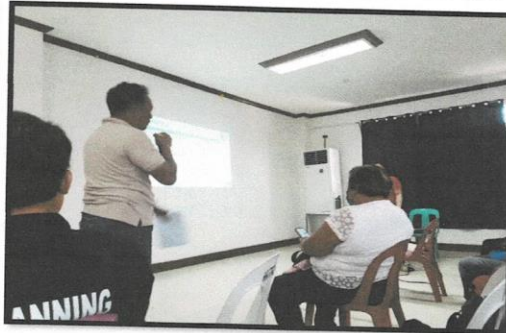
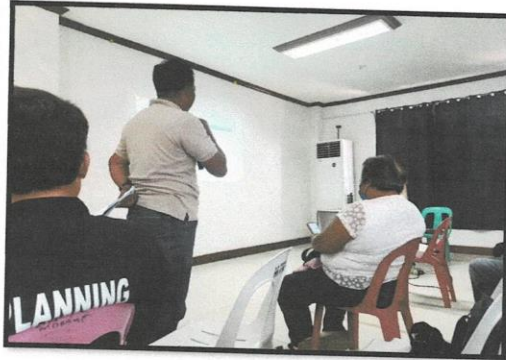
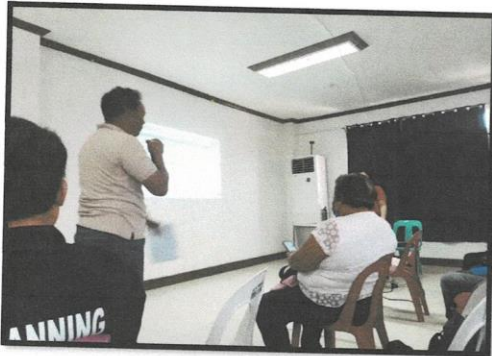
Please be informed that during the discussion, Ms. Delos Santos she explained that the issued tenurial instruments within the barangay was recognized before the issuance of the said Indigenous Rights of 1997. She clearly explained October 29, 1997 below the issued tenurial instrument such as Certificate of Stewardship Contract (CSC), FLAgT, Certificate of Title and other tenurial instruments was recognized.

During the open forum the undersigned informed the body/Ms. Delos Santos that our office, there are issued Certificate of Stewardship Contracts (CSC) some are already expired and some are already renewed. Ms. Delos Santos explained that the expired CSCs they need to secure Free and Prior Informed Consent (FPIC) before renewing of the said expired CSCs.

Ms. Delos Santos she requested shape files of the issued tenurial instrument like FLAgT, Certificate of Title and CSCs within the said barangay.

The undersigned, I did not attend the scheduled activities as indicated in the letter of invitation, because according to Ms. Delos Santos they only conducted ocular inspection in the subject area of application and she said also that we will attend during the final delineation of the said application for CADT of Indigenous Peoples of Barangay Bulalacao, Coron, Palawan and informed this Office for final delineation.
