



“WHEREAS, Bulalacao is a Municipality that thrives with its agriculture resources, a home to productive forests or a forest lands that can be made available for timber and agro-forestry productions, range lands for grazing and other special uses;

“WHEREAS, Section 2(h) of Presidential Decree No. 705 s. 1975 states that “national park refers to a forest reservation essentially of primitive or wilderness character which has been withdrawn from settlement or occupancy and set aside as such exclusive to preserve the scenery, the natural and historic objects and the wild animals or plants therein and to provide enjoyment of those features in such a manner as well leave them unimpaired for future generations;

“WHEREAS, the main objective of this resolution is best described in the preceeding paragraph preserving certain areas within the timberland to be developed into a forest park that shall benefit the people and the community in terms of social and economic gains;

“WHEREAS, it is made known that there are interested private individuals who applied for titling within the timber land in Barangay Poblacion. The LGU-Bulalacao is in the process of conducting a survey in the said land having enough fund, so that it is requested that CENRO should hold any application for titling coming from private individuals; **Now, therefore, be it...**

RESOLVED AS IT IS HEREBY RESOLVED To: Request the Community Environment and Natural Resources Office (CENRO) through Engr. Caesar F. Quebec, CENR-Officer, San Mariano, Roxas, Oriental Mindoro to hold all applications for titling, Lot Nos. 36, 37, 38, 65, 66, 67, 85, 86, 10, 13 and 17 under Land Classification No. 622 classified as timberland/forest land situated in Barangay Poblacion, Bulalacao, Oriental Mindoro;

RESOLVED, FURTHER, To: Let copy of this resolution be furnished the Department of Environment and Natural Resources (DENR) and the Provincial Environment and Natural Resources Office (PENRO) for their information and appropriate action;


