**REQUESTING THE OFFICE OF MARIA ANTONIA YULO-LOYZAGA, SECRETARY OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), FOR AN UPDATE ON THE STATUS OF YOLANDA HOUSING PROGRAM IN BARANGAY SAN NICOLAS, CORON, PALAWAN.**

**WHEREAS**, the Municipality of Coron is one of the beneficiaries of the Yolanda Housing Program of the national government thru the National Housing Authority (NHA) which was tasked to develop and implement a comprehensive and integrated housing project for the super typhoon Yolanda victims;

**WHEREAS**, more or less 2,670 families occupying the hazard prone areas in the municipality are the primary recipients of shelter from this housing project once completed;

**WHEREAS**, the DENR-MIMAROPA issued a cease and desist order to the contractor of the project due to a dispute over the ownership of the site, which, according to said agency belongs to Yulo King Ranch (YKR), nevertheless, the contractor has already built 600 units but there is currently no clear resolution to resume the construction;

**WHEREAS**, for the project to be realized in order to benefit the affected families after a decade that this calamity occurred, this August Body deemed it necessary to seek assistance from the Department of Environment and Natural Resources (DENR) and the Department of Human Settlement and Urban Development (DHSUD) for the immediate solution of this matter;

**NOW THEREFORE**, on motion of the Honorable Philip Andrew A. Astor, SB Member/Majority Floor Leader, and unanimously seconded by all members present, be it,

**RESOLVED AS IT IS HEREBY RESOLVED**, requesting the office of Maria Antonia Yulo-Loyzaga, Secretary of the Department of Environment and Natural Resources (DENR), for an update on the status of Yolanda Housing Program in Barangay San Nicolas, Coron, Palawan;

**REQUESTING THE SECRETARY OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), HON. MA. ANTONIA "TONI" YULO-LOYZAGA, THRU THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO), PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (PENRO) AND DENR REGIONAL OFFICE FOR THE IMMEDIATE CORRECTION OF THE CADASTRAL MAP OF THE MUNICIPALITY OF CORON, PALAWAN DUE TO INCONSISTENCIES AND CONFLICTS ON ITS BORDERS AND BOUNDARIES.**

**WHEREAS**, the Municipality of Coron comprises of twenty three (23) barangays that are separated by their respective boundaries with the coastal barangays and the mainland situated apart by the surrounding municipal waters;

**WHEREAS**, a cadastre/cadaster is essential in terms of obtaining a comprehensive recording of the real estate's metes-and-bounds of a certain place, may it be a country, province, city or municipality, which is represented graphically in a cadastral map;

**WHEREAS**, the cadastral map of Coron, in particular, has disputing boundaries in Barangay Poblacion 1,2,3,4, Barangays Tagumpay, Marcilla, Borac and Guadalupe, and it did not include Barangay San Jose as well;

**WHEREAS**, these conflicting borders may result to inconsistencies both in barangay and municipal data, hence the need to seek the assistance from the DENR as well as its regional, provincial and local offices, to correct all the information indicated in the cadastral map of this municipality;

**NOW THEREFORE**, on motion of the Honorable Michael G. Sadhwani, SB Member/Temporary Majority Floor Leader, and unanimously seconded by all members present, be it,

**RESOLVED FURTHER**, that copies of this resolution be given the **DENR, CENRO, PENRO** and **DENR Regional Office**, and be furnished the **Office of the Mayor** and all offices and agencies concerned, *for their information and appropriate action*;
