CONDUCT OF WORKSHOP FOR THE NATIONAL INTEGRATION AND STANDARDIZATION OF FORESTRY SPATIAL DATASETS (FSD) TO BE HELD ON 6-10 MARCH AND 13-17 MARCH, 2023 IN REGION 4A

Rationale

To effectively safeguard, develop, and maintain the nation's remaining forest resources, forestlands, and watersheds, the Forest Management Bureau (FMB) embraced current technologies such as the Geographic Information System (GIS) and Remote Sensing (RS) in its policies and guidelines since 2012.

GIS is a computer-based system designed to capture, store, manipulate, analyze, manage, and present all types of spatial or geographical data¹. It is considered a tool in monitoring, policy, and decision-making to effectively and sustainably manage our natural resources.

Since July 2021, the Bureau has been conducting a series of consultation workshops to develop a guidebook that will contain the data dictionary and geospatial standards for identified forestry spatial datasets. During these consultations, the use of GIS in transforming non-spatial forestry-related reports was also discussed, such as but not limited to forest inventory, potential investment areas, location of Wood Processing Plants (WPP), tree replacement areas, construction of Small Water Impounding Structure (SWIS), Lawin patrol data, location of log apprehension, and occurrence of forest fire incidence into spatial datasets.

To ensure the effectiveness of the output of these workshops, a pilot testing was conducted in Regions 2, 3, and 4A. Further comments gathered during the pilot test were consolidated and integrated in the Guidebook of FSD. In December 2022, a workshop was also conducted to develop the Forestry Spatial Dataset portal to house the said data.

In view of this said activities, a national workshop is necessary to assist and guide the DENR Field Offices in using the said guidebook. The workshop will also be an avenue to assist the regions in the preparation of the forestry spatial datasets

Objective

This workshop aims to capacitate the DENR Field Offices on the methodologies in preparing the database of the integrated and standardized forestry spatial data sets. Specifically, it aims to:

- a. Capacitate DENR Field offices in identifying, assessing and integrating existing forestry spatial datasets being managed and analyzed by the DENR Field Offices;
- b. Capacitate DENR Field Offices in transforming forestry-related reports and accomplishments into spatial datasets and prepare attribute based on the standards stated in the FSD Guidebook;
- c. Initially complete the updating of forestry tenure instruments based on the proposed standards; and
- d. Present the final draft of the DENR Memorandum Circular covering the implementation of the FSD Guidebook
