SUBJECT : SUBMISSION OF ACCOMPLISHMENT REPORT FOR ACTIVITIES RELATED TO THE TASK FORCE BUILD BACK BETTER AS INPUTS TO THE PRESIDENT'S 2023 STATE OF THE NATION ADDRESS (SONA)

DATE : 29 March 2023

This refers to the preparation of the Task Force Build Back Better accomplishment report as inputs for the President's 2023 State of the Nation Address (SONA). As mandated by Executive Order No. 120, the Task Force shall focus on the post-disaster rehabilitation and recovery phase in typhoon-affected areas, beginning with those hit by typhoons Rolly and Ulysses.

In a memorandum dated 16 March 2023, Senior Undersecretary and Head, Elaine T. Masukat, Presidential Management Staff (PMS), Office of the President (OP), directed all Department Secretaries and Agency Heads to prepare concise and factual agency accomplishments for the first year of this Administration to be reported in the 2023 SONA. Moreover, all Departments are instructed to consolidate reports from their respective attached agencies to ensure that inputs are focused primarily on major accomplishments.

May we request for the submission of key accomplishment reports that cover the regions' build back better initiatives based on the six (6) Key Result Areas, as follows:
