This pertains to the letter of Mr. Mario R. Sarmiento, SAMAPA Chairman dated 21 November 2022 which was received by this Office on 01 March 2023 inquiring on the land classification of Lot No. 1605 CAD 1150-D located in the Northern part of Busuanga Airport, Brgy. Decalachao, Coron, Palawan.

Upon evaluation of the request, please be informed that this Office has no available data (Map) to verify whether the area specified in his letter is within the jurisdiction of the Busuanga Pasture Reserve. Hence, we would like to refer the matter to your Office for your verification/review.

Also, we would like to reiterate that the whole BPR was withdrawn from "sale, settlement or any other form of disposition, exploration or exploitation and reserve as a pasture reserve". Hence, the whole 40,000 hectares of BPR area was reclassified into forestland, including the areas which were formerly classified as agricultural Alienable and Disposable (A&D) land.

It must also be emphasized that PP 1387 was issued during the effectivity of the 1973 Constitution¹, when the legal classification of lands still includes "grazing lands". However, the said land classification was removed in the 1987 Constitution, and the Grazing or pasture land as a classification was consolidated into forest or timber land². Hence, in case the said lot falls within the BPR, the said Lot is classified as forestland.

We will highly appreciate if you could inform Mr. Sarmiento of your action taken on the matter, copy furnished this Office.

¹ Article XIV of the 1973 Constitution, Section 10. Lands of the public domain are classified into agricultural, industrial or commercial, residential, resettlement, mineral, timber or forest, and grazing lands and such other classes as may be provided by law.

² 1987 Constitution, Section 3. Lands of the public domain are classified into agricultural, forest or timber, mineral lands and national parks. Agricultural lands of the public domain may be further classified by law according to the uses which they may be devoted. Alienable lands of the public domain shall be limited to agricultural lands.


