Kaya po wrong planning and implantation itong causeway sa harap ng aming bayan.


Basta nalang nag plano na walang consultation and pag aaral.

Madam:

Greetings in conservation!

This refers to your concern lodged to the DENR with tracking number DENRCO-OSEC-2022-003252 that recently received by this Office on 14 February 2023 requesting to conduct investigation on the DPWH Project along the seashore of Calatrava, Romblon.

Please be informed that this Office conducted field investigation on the said subject matter in collaboration with DENR-Environmental Management Bureau (EMB), DPWH-District Engineering Office (DEO) and Municipal LGU of Calatrava, Romblon on 8 February 2023. It ascertained that the said beachfront do not possess critical habitat like sea grass/mangrove ecosystem and not even declared as marine protected area.

Accordingly, the DENR-EMB MIMAROPA Region issued Notice of Violation (NOV) dated 10 February 2023 on the basis of constructing a causeway project with reclamation component without approved Environmental Compliance Certificate (ECC) under Item 3.5.3 of EMB MC No. 2014-005. Thus, this memorandum provides that a causeway project with reclamation component require an ECC prior to project implementation.

Since it falls under reclamation, the Philippine Reclamation Authority (PRA) has jurisdiction over the said project and the proponent shall apply "AREA CLEARANCE" from the DENR as one of the requirements.

Moreover, Regional Director Joe Amil M. Salino already directed the DPWH-DEO to SUSPEND any further developments relative to the construction and operation of the causeway project including the reclamation activities upon receipt of the said Order.

Again, thank you very much and we hope that we have addressed this concern accordingly.

This is to acknowledge receipt of your email complaints dated 21 and 22 February 2023 in relation to the alleged ongoing construction of Surwest Construction and Development Corporation of the Causeway project located at Brgy. Poblacion, Calatrava, Romblon.

Please be informed that this Office has already issued a Notice of Violation (NOV) dated 10 February 2023 against the project for undertaking reclamation activities without a valid Environmental Compliance Certificate (ECC) issued by this Office. Furthermore, the DPWH - Romblon District Engineering Office was also directed to SUSPEND any further developments relative to the construction and operation of the causeway project including the reclamation activities EFFECTIVE IMMEDIATELY upon receipt of the NOV until and unless a valid ECC has been secured.


In addition, it was agreed during the Technical Conference conducted last 13 February 2023 that a Certification shall be secured from the Philippine Reclamation Authority to determine whether the causeway project involves reclamation activities and that an ECC application shall be filed before our Office. As a matter of due process, we have also required DPWH to submit a Position Paper within ten (10) days from the conduct of Technical Conference to explain their side in connection with the abovementioned violation.

Moreover, we have already referred this matter to the Office of the Regional Director, DPWH -MIMAROPA Region for the updating status of the project and compliance with regard to the abovementioned NOV and Technical Conference.
