AGREEMENT (CBFMA) BY CY 2024**

Pursuant to Section 18 of DENR Administrative Order No. 2004-29 “Revised Rules and Regulations for the Implementation of Executive Order 263, Otherwise Known as the Community-Based Forest Management Strategy”, stated that the Community Resource Management Framework (CRMF) shall be prepared within thirty (30) days after the approval of the CBFMA. Further, under FMB Technical Bulletin No. 20 “Enhanced Guidelines and Procedures in the Preparation/ Updating of the CRMF and Five-Year Work Plan (FYWP)”, it clarified that the CRMF formulation shall be done by the CBFM-POs and to be facilitated by the DENR.

Further, the Region is being reminded that the CRMF shall serve as the framework/guide in project implementations of the said CBFM-PO and shall explicitly express their vision and goal, existing resources in the CBFM area covered by the Agreement and development approaches, among others. While their FYWP, consistent with the CRMF, shall contain the detailed strategies, activities and targets for five years on protection, rehabilitation, development and resource utilization, organizational strengthening, financing, marketing and enterprise development, among others.

Relative thereto, please ensure the completion of the formulation of CRMF and FYWP of all issued CBFMA in your respective regions by CY 2024. This is to ensure that the CBFM-POs have proper directions/guides particularly their development in the CBFM areas and to improve forest investment in their tenured area towards sustainable forest management.
