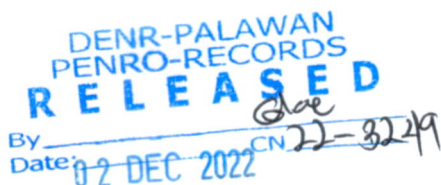

**CHRONOLOGY OF EVENTS:**

1. October 2, 2019 Approval of Tenurial Instrument of SPRC.
2. October 30, 2019 Made their payment for the annual Government Share and Performance Bond. (See table above )
3. October 1, 2020 SPRC requested deferment of remittance of its Annual Government Share until October 2021 due to COVID 19 pandemic.
4. February 23, 2021 CENRO Roxas was not able to hit its annual target (CY 2020) due to non-payment of SPRC for the period October 2020- October 2021, thus a letter was sent to remind them of their obligation on this date.
5. March 10, 2021 Mr. Worsdell, CEO of SPRC replied to our letter dated Feb. 23, 2021 reiterating his pending request for deferment of payment of government share addressed to DENR Central Office on October 14, 2020.
6. July 29, 2021 A letter was sent to SPRC with regards to a memorandum from the Regional Executive Director dated July 13, 2021 relative to the revaluation of Government Share for FLAgT purposes and new schedule of payment of government share for SLUP, FLAg and FLAgT.  
  
A memorandum was later on received on September 30, 2021, clarifying that revaluation of government share of SPRC will commence on the year 2024 and not on year 2022 in contrast with July 13, 2022 memorandum.
7. August 27, 2021 SPRC made their payment both for the Annual Government Share and Back Rental fee for the period October 2020- October 2021. (See table above) This is the period where they requested deferment of payment.
8. Sept. 10, 2021 SPRC made their payment for annual government Share for the period covered October 2021-October 2022.
9. October 6, 2021 Memorandum from the office of Regional Executive Director in reply to the request of SPRC for deferment of payment of its annual Government Share was received by this office.  
  
This time, SPRC have already paid their obligation (See No. 8). We did not imposed any surcharges due to abeyance of resolution of this concern of SPRC as instructed.
10. October 28, 2021 SPRC made their payment for Government Share- Back rental fee for the period covered October 2021- October 2022.

Because of these payments of SPRC for two (2) periods (Oct. 2020-2021 and Oct. 2021-2022) on CY 2021, SPRC have no longer outstanding obligation.

11. March 17, 2022 A letter was sent to SPRC reminding of DAO 2021-02,- the new due date for payment of annual government share.
12. March 23, 2022 Conducted compliance monitoring and submitted the report on April 4, 2022. At this time, SPRC have not yet paid their obligation in spite of our reminder before and days after the monitoring.
13. September 2, 2022 A letter was again sent reminding their obligation pursuant to DAO 2021-02.
14. Sept. 28, 2022 We have sent another letter showing a sample computation of surcharges we may impose due to their late payment.
15. Sept. 30, 2022 SPRC made their payment for annual Government Share for the period covered Oct. 2022-Oct. 2023.
16. October 27, 2022 SPRC made their payment for Government Share-Back rental Fee for the period covered Oct. 2022- Oct. 2023.

With the above information, we would like to clarify the surcharges we may impose to SPRC due to their late payment pursuant to DAO 2021-02. Please take note that on March 31, 2022, SPRC have paid their obligation until Oct. 31, 2022 (See No. 8 & 10), thus imposition of surcharges on months wherein technically they are paid is unconscionable.

However, on the other hand, if we treat their payment for the period covered Oct. 2021- Oct. 2022 as advance payment for March 31, 2022 due date, and not impose surcharge, their payment for the period covered Oct. 2022- Oct. 2023 might as well be treated as advance payment for March 2023. Then, their next due date will be on March 31, 2024- having no obligation to pay on CY 2023. This will have a great effect on our 2023 annual target since almost 90% of the target is from collection of revenues from SPRC (assuming no change /revaluation of government share of other FLAgT holders).

Attached herewith is the list of existing FLAGT with the corresponding revaluated Government Share (GS) in accordance to DAO 2004-28 Section 16. *Payment of Government Share and surcharges for late payment, to wit:*

*"The government share shall be five percent (5%) of the most recent zonal value of the commercial zone within the barangay, or the nearest and adjacent barangay within the municipality. A revaluation shall be undertaken every five (5) years thereafter.*

*The government share shall be paid within thirty (30) days upon issuance of the FLAGT and annually thereafter within the same month that the FLAGT was issued. Failure to pay within the prescribed period shall be subject to surcharges of 8.33% monthly for late payment or 100% for one (1) year."*

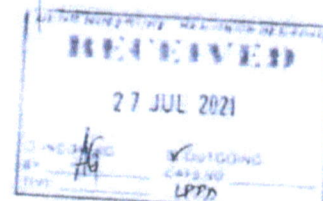
In view hereof, you are advised to notify the concerned holders of FLAGT under your jurisdiction of the new Annual Government Share required to be paid to the concerned DENR Field Office. Please be reminded that starting year 2022, the payment of government share shall be on or before March 31 pursuant to DAO No. 2021-02 (copy attached). Kindly note that said DAO amends Section 16 of DAO 2004-28 and Section 18 of DAO No. 2004-59 which states that:

*DAO 2021-02 Section 1. Amendments to DAO Nos. 2004-28 and 2004-59*

*"The government share or user's fee for SLUP, FLAG and FLAGT shall be paid within thirty (30) days upon issuance of SLUP, FLAG and FLAGT and annually thereafter on or before March 31 of the succeeding years. Failure of the SLUP, FLAG and FLAGT holder to pay the user's fee within the prescribed period shall be subject to surcharges of 8.33% monthly for late payment or 100% for one (1) year."*

With regards to the conducted revaluation of government share for FLAGT, please be informed that this office had a meeting with FLAG and FLAGT stakeholders in Palawan way back July 26, 2018 for Southern Palawan and August 4, 2018 for Northern Palawan to inform/remind the holders of the said activity which is in accordance to existing rules and regulations relative to BIR zonal valuation issuances. This office had also forwarded the list of the revaluated GS and

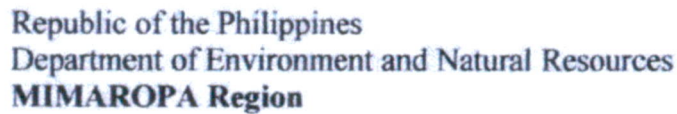

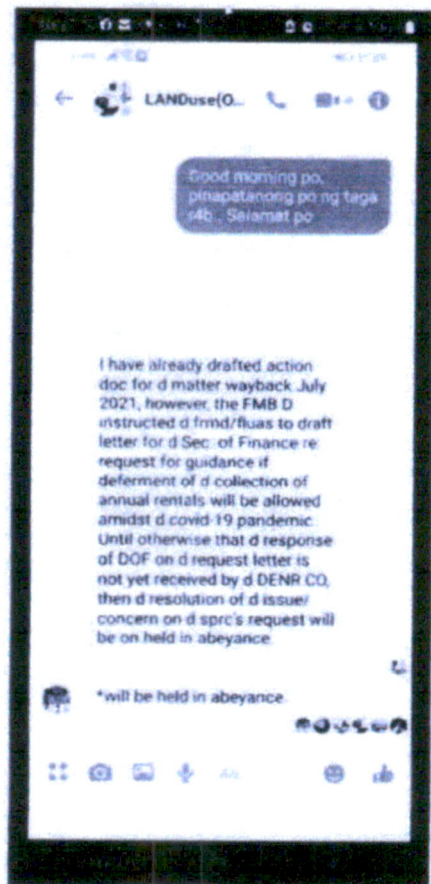
