The conduct of re-inventory is vital in gathering important information about the location, number, measurement, volume, tree number, and species of trees removed/damaged as reported, for purposes of filing a complaint if warranted as per your Joint Order dated February 6, 2023.



## MINUTES OF THE TECHNICAL CONFERENCE WITH ALTAI PHILIPPINES MINING CORPORATION (APMC)

A technical conference was held at PENRO Conference Room, Barangay Tabing-Dagat, Odiongan, Romblon on March 08, 2023 at 1:30 PM.

The following are the highlights of the conference:

- ARNOLDO A. BLAZA JR., the OIC, PENRO, explained the reasons why the Notice of Violation (NOV) dated February 3, 2023 was issued;
- The APMC understood the side of the PENRO. However, APMC, thru its legal counsel ATTY. MARY JANE BALAGTAS, is requesting the copy of the investigation reports (on alleged clearing/ affected areas and damage to marine life and sea grass) as the basis of the issuance of the above-mentioned NOV. As manifested, they will write concerned offices to request official copies of the reports transmitted by the PENRO;
- It was explained that a Notice of Violation is actually similar to a Show Cause Order. It is
  just a notice which directs a concerned party why it should not be found liable for any
  possible violation. Hence, APMC is still entitled to due process, including holding of
  today's Technical Conference; and
- The APMC's positions, particularly as to the reason why they did not give consent to give access to PENRO to conduct inspection on February 7, 2023, are well taken. Moreover, it gives its consent on the conduct of the re-inventory of trees immediately within the Parcels 1, 2, and 3 and the twenty (20) hectares of APMC's area of operation at Sitio Bato, Brgy. España, San Fernando, Romblon, provided that the company's representatives are present.

The conference ended at 4:00 PM of the same day.
