Pasadeña, El Nido, Palawan. No oil spill was observed in the said area during the monitoring. However, some trash was observed scattered on the beach.

Hence, this office will conduct continuous monitoring regarding the oil spill caused by the sunken MT Empress within the Protected Area, and will schedule the conduct coastal clean-up.
