In line with the implementation of the NIPAS Act, as amended, and as part of the Coastal and Marine Ecosystems Management Program (CMEMP), the Biodiversity Management Bureau (BMB) is pleased to inform you that an **Orientation on DAO 2021-13 of the Guidelines for the Development and Recognition of BDFE for its implementation in terrestrial ecosystems and a refresher course on Business Development Services (BDS)** will be conducted this CY 2023 with the following clusters and schedules:

The BDFE Program intends to cover terrestrial protected areas and other conservation areas in consideration of the lessons learned from its implementation in marine PAs. As part of this effort, the Bureau conducted the first Orientation for the PAMO personnel in selected terrestrial protected areas, including representatives from CDD, through virtual platform in CY 2022. To ensure that field implementers are equipped with the necessary skills and knowledge to effectively implement the BDFE Program, it is essential to provide continuous and periodic orientation through various workshops and learning events.
