

Respectfully forwarded is the memorandum dated May 10, 2023, of OIC-CENRO Pedro A. Velasco together with the spot report dated May 8, 2023, of MES personnel relative to the apprehension of 123 pcs. of Burawis lumbers with an equivalent volume of 808.47 Bd.ft. of various sizes and dimensions in Barangay Tagabinet, Puerto Princesa City.

Please be informed that the said illegally cut/sliced lumbers were apprehended by the CENRO-MES personnel, without a permit and in violation of Section 77, Presidential Decree 705, known as the Forestry Code of the Philippines. Accordingly, the said illegally cut lumbers were owned by certain Mr. Ryan Relova but were apprehended under the possession of the haulers in the name of Richard Laude and Pablito Omam.

Be informed further that the said apprehended lumbers are temporarily deposited at the Barangay Hall of Tagabinet under the custody of Punong Barangay Juvylyl C. Bonda. Hence, this office instructed the concerned CENRO to immediately haul the said illegally cut lumbers from Barangay Tagabinet to CENRO Puerto Princesa City and conduct an administrative adjudication in consonance with the provision of DAO 97-32.

1. WHAT: Violation of Sec.77 of PD 705
2. WHO: a. RYAN D. RELOVA- alleged owner of the lumber and resident of Bgy. Cabayugan, Puerto princesa City
b. RICHARD LAUDE- Hauler, and resident of Bgy. Cabayugan, PPC
c. PABLITO OMAN- Hauler, and resident of Bgy. Cabayugan, PPC
- d. WHEN: May 8, 2023, 5:00 PM
- e. WHERE: Bgy. Tagabinet , Puerto Princesa City
- f. HOW:

On May 08, 2023, more or less 5:00 in the afternoon the undersigned and other MES personnel, while on our way going to Brgy. Hall of Tagabinet spotted a stockpile of lumbers more or less 10 meters from the national highway. The team disembark from the vehicle and approached the two persons piling the said lumbers. We introduced ourselves as DENR employees and asked them if they possessed permits or any legal documents for the lumber. The two persons identified themselves as RICHARD LAUDE and PABLITO OMAN who were haulers hired by Mr. Relova who they claim as the owner of the lumbers. They presented us with a photocopy of Brgy. Certification dated July 4, 2022, issued by PB Rolly Francia who grants and certifies the cutting of fallen trees due to typhoon Odette, a photocopy of the letter dated July 24, 2022, addressed to PPSRNP requesting to cut trees within Lot number 4 located at So. Crossing, Bgy. Cabayugan, PPC, a photocopy of chainsaw registration, and photos of felled trees requested to be cut. Aside from these documents, no other paper was presented that would show that the hauling and possession of the said lumbers were legal, hence the team decided to apprehend the lumbers. With the help of Punong Barangay Juvylyl C. Bonda and their Bgy. Tanod we hauled the lumbers to Tagabinet Bgy. Hall for temporary custody. While loading the said lumbers to the rented PUJ, a person named Ner Relova approached the team and introduced himself as the father of Mr. Ryan Relova, we asked him for the permit of the lumbers but he was not also to show any, the apprehension receipt was handed over to him in behalf of his son and the two haulers.

Due to time constraints and security reasons, the team inventoried the lumbers in Bgy. Hall of Tagabinet, the designated temporary impounding area, the day after the

apprehension, May 09, 2023, and the result shows that there was a total of 123 pcs Burawis lumber with an equivalent volume of 808.47 Bd.ft.

The lumbers were currently deposited at Brgy. Hall of Tagabinet under the custody of Punong Barangay Juvylyl C. Bonda.

Given the foregoing, the undersigned recommends that an administrative adjudication be conducted according to DAO 97-32, and the filing of a criminal case if the evidence and circumstances warrant.



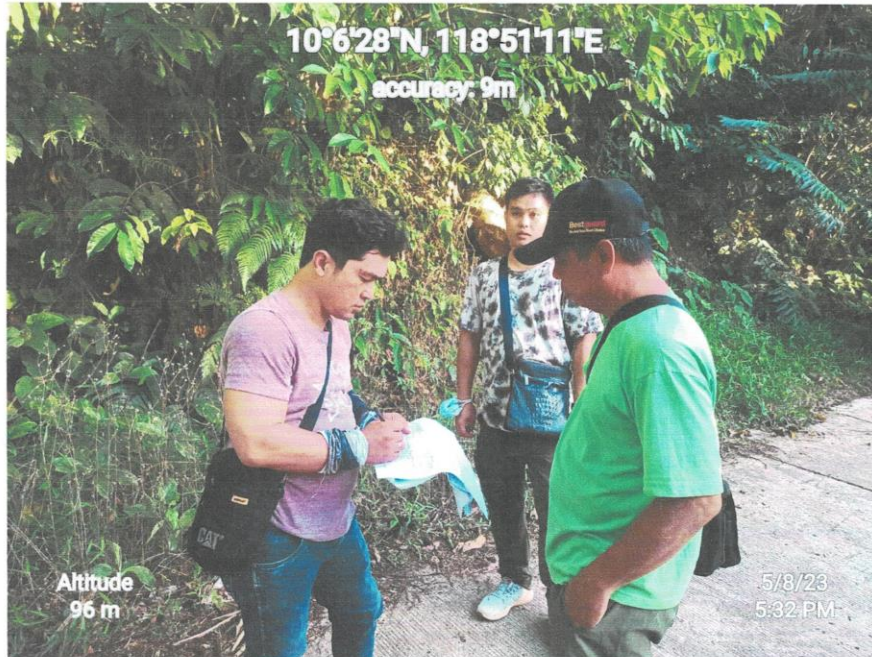


Figure 1 Photo Showing DENR personnel handing over a copy of the apprehension receipt to Mr. Ner Relova
