Warm greetings!

We would like to express our heartfelt gratitude and appreciation for your continued support to the people of the Municipality of Bulalacao, Province of Oriental Mindoro.

This pertains to our request and appeal for your intervention in reducing the seventeen thousand (17,000) hectares to ten thousand (10,000) hectares of the proposed Certificate of Ancestral Domain Claim/Title (CADC/CADT).

As stated also in our previous letter, such area is already almost one half of the total land area of Bulalacao. The government itself needs space for future development most especially for the economic zone/industrial park which has been included in our approved Comprehensive Land Use Plan (CLUP) as well as to support our vision of becoming the agri-tourism hub of Oriental Mindoro. In addition, there are also members of the tribal community of Hanunuo Mangyans, particularly in Barangay Benli, who prefer having their properties titled and do not want to be included in the proposed CADC/CADT.

In this connection, we would like to respectfully request for an update regarding this concern.

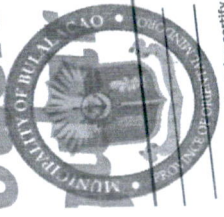
