**SUBJECT : COMPLETE STAFF WORK (CSW) ON THE PROPOSED NICKEL PROJECT OF ALTAI PHILIPPINES CORPORATION IN SAN FERNANDO, SIBUYAN ISLAND, ROMBLON.**

In reference to the mandated environmental laws and other related issuances particularly Presidential Decree No. 1586 otherwise known as the Philippine Environmental Impact Statement System (PEISS), Republic Act 9275 otherwise known as the Philippine Clean Water Act of 2004, among others, in connection to the activities of the Altai Philippines Mining Corporation (APMC), the undersigned technical personnel are respectfully submitting the Complete Staff Work (CSW) on the Altai Philippines Mining Corporation (APMC)'s Nickel Mining Project located at the Province of Romblon.

### I. BACKGROUND INFORMATION

This Office acquired jurisdiction over the Altai Philippines Mining Corporation (APMC) through regular monitoring of its compliance with environmental laws (*i.e.*, RA 8749 (Clean Air Act of 1999), RA 9003 (Ecological Solid Waste Management Act of 2000), RA 9275 (Philippine Clean Water Act of 2004), RA 6969 (Toxic Substances and Hazardous and Nuclear Waste Control Act of 1990), and PD 1586 (Philippine Environmental Impact Statement)).

On January 6, 2023, the EMB Central Office through its official website, posted a Notice of Public Scoping in favor of APMC along with the Project Description Report (PDR). The said scoping activity was scheduled on January 19, 2023, at Covered Court, Sitio Talaba, Brgy. Taclobo, San Fernando, Sibuyan Island, Romblon.

On January 9, 2023, the EMB Regional Office received a Memorandum from the EMB Central, requesting a representative to **facilitate the Public Scoping** for the proposed **Nickel Project** of APMC.

### II. LEGAL BASIS

- DENR Administrative Order No. 2003-30: Implementing Rules and Regulations (IRR) for the Philippine Environmental Impact Statement (EIS) System;
- EMB MC 2014-005: Revised screening Guidelines and Standardized Requirements in the Philippine EIS System;
- DENR Administrative Order No. 2017-15: Guidelines on Public Participation under the Philippine Environmental Impact Statement (EIS) System;
- RA 6969 or the Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990 and its Implementing Rules and Regulations (IRR); and
- RA 9275 or the Philippine Clean Water Act of 2004 and its IRR.

### III. TENEMENT HISTORY OF THE MINING CORPORATION

The history of the compliance process to other government agencies by the above-subject mining company was initially discussed below, to wit:

- **On June 23, 1972**, a lease-of-contract (PLC-V-547) was awarded to Sta. Barbara Development Corporation and exploration works were subsequently implemented in the covered property.
- **On February 20, 1996**, presidential proclamation no 746 was executed by the late president Fidel V. Ramos, proclaiming Mt. Guiting -guiting as Natural Park with an area of 15,265.48 Hectares.
- **On March 19, 1996**, Sta. Barbara Development Corporation (STABADECO) and Altai Philippines Mining Corporation (APMC) signed a Deed of Assignment, wherein STABADECO transferred its PLC-V-547 to APMC.
- **On May 21, 1996**, APMC filed Mineral Production and Sharing Agreement (MPSA) application (AMA-IVB-025) with MGB Regional Office for 1,854 hectares.
- **On November 9, 2004**, a Memorandum of Understanding (MOU) was executed between APMC (Claimowner), Sunshine Gold Party Ltd, Sunpacific Resources Philippines, Inc., and All Acacia Resources, Inc. (Operators) in relation to the pending MPSA application.
- **On May 03, 2005**, a Certification of Pre-condition (ADO-CP-IV-05-05-0243) was issued by the National Commission on Indigenous Peoples (NCIP)
- **On December 23, 2009**, the MPSA (No. 304-2009-IVB) was executed between the APMC and the Department of Environment and Natural Resources (DENR).
- **On August 20, 2010**, The Sangguniang Bayan Members of the Municipalities of San Fernando, Cajidiocan, and Magdiwang, Romblon adopted **Joint Resolution No. 01-10** opposing all forms of metallic mining in the Sibuyan Island, Romblon Province and at the same time, the then DENR Secretary, Ramon Paje, was requested to revoke all metallic mining permits issued in Sibuyan Island. **Joint Resolution No. 02-10** was also passed, requesting the then President, Benigno Simeon C. Aquino III, and the Congress of the Philippines to declare Sibuyan Island, Province of Romblon free from all forms of metallic mining.
- **On September 7, 2010**, APMC executed a Deed of Assignment, transferring its rights and interest over the MPSA (No. 304-2009-IVB) to Sibuyan Nickel Properties Development Corporation (SNPDC).
- **On September 23, 2010**, an agreement on the Assumption of Rights and Obligations was executed by and between Sunshine Gold Pty Ltd, Sunpacific Resources Philippines, Inc, All Acacia Resources, Inc. (Operators), and SNPDC with respect to the mineral property of APMC.
- **On September 24, 2010**, the Deed of Assignment between APMC and SNPDC was registered to DENR-MGB. To this present date, however, the process and evaluation did not proceed and APMC retained its title as the MPSA Holder.
- **On January 10, 2011**, Governor Eduardo Firmalo issued **Executive Order No. 001 series of 2011** declaring a moratorium on the exploration, excavation, extraction, and utilization of metallic minerals in the province of Romblon. The said EO also created a special task force to spearhead an assessment of all mining applications, permits, and operations existing in the province and to review the MPSA granted to Altai Philippines Mining Corporation (APMC). On the same date, the Sangguniang Panlalawigan of Romblon passed **Resolution No. 01-2011-23 strongly supporting EO No. 001, series of 2011** on the declaration of a moratorium on all mining activities in the province of Romblon.
- **On January 24, 2011**, the Sangguniang Panlalawigan of Romblon passed **Resolution No. 01-2011-41**, withdrawing support to the Sangguniang Panlalawigan of Romblon Resolution No. 01-2011-23 which strongly supports EO No. 001, series of 2011.

- On **June 07, 2011**, filing of **House Bill No. 4815, "Declaring the Province of Romblon A Mining Free Zone"**.
- On **September 13, 2011**, a complaint was filed by Mayor Dindo Coronel Rios against the APMC due to the alleged danger of mining activities in the rivers and streams of Sibuyan Island.
- On **September 19, 2011**, a Cease-and-Desist Order (CDO) was issued by the DENR-Mines and Geosciences Bureau.
- On **September 21, 2011**, Sibuyan Nickel Properties Development Corporation responded by asking for the lifting of the Cease-and-Desist Order issued by the MGB,
- On **October 03, 2011**, the Counsel for Sibuyan Nickel Properties Development Corporation wrote a letter attaching the approved Exploration Work Program, dated December 23, 2009, arguing that the issued order has no basis in fact and in law.
- On **October 04, 2011**, Counsel for Sibuyan Nickel Properties Development Corporation wrote a letter to the then DENR Secretary, Ramon Paje, inquiring about the action taken by the DENR and requesting the lifting of the issued Cease-and-Desist Order by the MGB.
- On **April 26, 2012**, a verified petition for Declaratory Relief under Rule 63 of the Rules of the Court was filed by Sibuyan Nickel Properties Development Corporation praying for the declaration of the nullity of Executive Order No. 001, series of 2011 issued by then Provincial Governor of Romblon, Eduardo C. Firmalo.
- On **January 17, 2013**, Governor Firmalo's Executive Order No. 1 series of 2011, prohibiting the "exploration, excavation, extraction and utilization of metallic minerals" in Romblon has been ruled **UNCONSTITUTIONAL** by Judge Ramiro Geronimo of the Regional Trial Court in Romblon.
- On **August 06, 2021**, the MGB MIMAROPA submitted its recommendation on the Appeal of Altai for lifting the September 19, 2011-CDO in compliance with the directives of the DENR MGB Central Office.
- On **September 09, 2021**, the issued CDO by the DENR-MGB was lifted.
- On **November 10, 2021**, the Deed of Assignment of Mining Rights/Properties filed by APMC in favor of SNPDC was withdrawn.
- On **July 12, 2022**, the first renewal of the exploration period under the approved MPSA was issued by the DENR MGB to APMC.
- On **December 29, 2022**, the Mines and Geosciences Bureau issued a **Mineral Ore Export Permit (MOEP)** with Reference No. **DENR-MGB-22-008** and **Ore Transport Permit (OTP)** No. **OTP-APMC-162-001-2022-MIMAROPA** in favor of Altai Philippines Mining Corporation (APMC), valid until January 28, 2023.






## V. CONCLUSION/REMARKS
