## RESOLUTION

For consideration before this Office is the payment made by herein Respondent relative to the Notice of Violation issued against the project dated 02 February 2023 for violating R.A. 9275 and its Implementing Rules and Regulations, as evidenced by a copy of the Official Receipt (OR) No. 0849373B dated 02 February 2023 covering the amount of FORTY SEVEN THOUSAND ONE HUNDRED FIFTY EIGHT PESOS AND 96/100 CENTAVOS (Php 47,158.96).

**WHEREFORE**, the above-subject case is hereby formally **LIFTED**. This shall effectively remove this violation from the dockets of the Environmental Management Bureau-MIMAROPA Region, without prejudice to future actions that may be instituted against the Respondent as may be warranted by circumstances or law.

However, Respondent remains enjoined from discharging any wastewater into any body of land or water until and unless a Discharge Permit has been secured from this Office.

Respondent is also reminded to comply with all the environmental laws and regulations and to secure all environmental permits and clearances relative to its operations.

The Chief, Environmental Management Services – Romblon or his duly authorized representative is hereby directed to serve this Resolution within Seventy-Two (72) hours from receipt hereof. A report shall likewise be submitted to this Office within forty-eight (48) hours from service stating the proceedings taken therein.
