Greetings!

This refers to the photo copy of a *Petition for Review* dated April 11, 2022 for the Civil Service Commission (CSC) relative to the above-cited case submitted by Mr. Rada to this Office.

Section 66 of the 2017 RACCS provides that "xxx *In case the decision rendered by a bureau or office head is appealable to the Commission, the same may be **initially** appealed to the department head and then finally to the Commission and pending appeal, the same shall be executory only after confirmation by the Secretary concerned.*" (emphasis ours)

Section 68 also provides that "xxx *If the appellant/petitioner fails to comply with any of the above requirements within the reglementary period, the Commission shall direct compliance within a period of not more than ten (10) days from receipt thereof, with a warning that failure to comply shall be construed as failure to perfect an appeal/petition for review and shall cause its dismissal with prejudice to its refiling.*"

However, per Certification dated August 17, 2022 issued by the OIC, Records Section, Michelle B. Tuyan, only a *Petition for Review* dated April 11, 2022 for the CSC, and a Motion for Reconsideration dated August 04, 2021 were received by our Office.

In this regard, we would like to inquire whether the *Petition for Review* dated April 11, 2022 was duly filed before your Office, and whether an Order/Resolution was issued relative thereto, if any.
