The above complaint was forwarded to the DENR Action Center on 11 May 2023 and was endorsed to this Office on 16 May 2023, for appropriate action.

Based on records, this Office has issued a Cease-and-Desist Order dated 24 May 2023 to Mr. Marianito Padilla, resident of Barangay Poblacion 3, San Jose, Occidental Mindoro, in violation on Section 1 of Batas Pambansa Blg. 265<sup>1</sup>.

By virtue of the complaint, this Office is requesting for the conduct of investigation in the coastal barangays mentioned in the attached letter, to render appropriate action, and to furnish this Office a copy of the investigation report. The embedded personnel assigned in your Office may provide technical assistance for this undertaking.

Dear Mr. M. Padilla:

Please be informed that on 08 April 2022, CENRO – San Jose confirmed that you conducted illegal beach sand extraction in Aroma Beach, Barangay San Roque, San Jose, Occidental Mindoro.

The above-cited extraction of beach sand materials is strictly prohibited pursuant to Section 1 of Batas Pambansa Blg. (BPB) 2651, which provides that:

"Section 1. Any provision of law, presidential decree, rule or regulation to the contrary notwithstanding, the extraction of gravel and sand and such other activities as would erode or diminish the natural beauty of beaches are prohibited..xxx"

Hence, you are hereby ordered to immediately **CEASE AND DESIST** from conducting illegal beach sand extraction in the area. This is without prejudice to the filing of appropriate charges against you with the proper court for violation of the applicable provisions of BPB 265.

Please be guided accordingly.
