


This is to acknowledge receipt of your email dated 08 March 2023 alleging therein that you have already sent several e-mails for a request of a copy of the Notice of Violation (NOV) issued and the status of project/suspension relative to the ongoing construction of Sunwest Construction and Development Corporation of the Causeway project located at Brgy. Poblacion, Calatrava, Romblon.

Under Section 9 (a) of Executive Order No. 02, Series of 2016 entitled "Operationalization in the Executive Branch the People's Constitutional Right to Information and the State Policies of Full Public Disclosure and Transparency in the Public Service and Providing Guidelines Therefore<sup>1</sup>," provides that, "any person who request access to information shall xxx xxx **reasonably describe the information requested and the reason for, or purpose of, the request for information**". Please be informed that your request letter failed to provide the reason or purpose for securing copies of the above-mentioned documents.

As previously communicated to you by this Office, an NOV dated 10 February 2023 was issued against the project for undertaking reclamation activities without a valid Environmental Compliance Certificate (ECC) issued by this Office. Furthermore, the DPWH – Romblon District Engineering Office was also directed to suspend any further development relative to the reclamation activities upon receipt of the NOV until and unless a valid ECC has been secured. Certification shall likewise be secured from the Philippine Reclamation Authority to determine whether the causeway project involves reclamation activities.
