The Committee on Public Services would like to invite you as a resource person to the Public Hearing on **23 May 2023, Tuesday, 10:30 a.m.** at the Pecson Room, Senate of the Philippines, Pasay City to discuss the following matters:

1. **SENATE BILL NO. 104**: An Act Allowing and Regulating the Use of Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code, and for other Purposes *(Introduced by Sen. Grace Poe)*;

4. **SENATE BILL NO. 1328**: An Act Recognizing Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code and Republic Act No. 7160, Otherwise Known as the Local Government Code, as Amended, and for other Purposes *(Introduced by Sen. Imee R. Marcos)*; and

5. **SENATE BILL NO. 1465:** An Act Allowing And Regulating the Use of Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code, and for other Purposes (*Introduced by Sen. Ramon Bong Revilla Jr.*).

Kindly submit your agency's position paper and any other supporting information/document on the above-cited matter. For your reference, the measures are attached with this letter.
