In reference to the electronic mail received by our Office on 17 May 2023, the Senate Committee on Public Services chaired by Senator Grace Poe will be conducting a hearing on **23 May 2023, (Tuesday) 10:30 AM at the Pecson Room, Senate of the Philippines, Pasay City** to discuss the following measures:

1. **SENATE BILL NO. 104:** An Act Allowing and Regulating the Use of Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code, and for other Purposes (Introduced by Sen. Grace Poe);
2. **SENATE BILL NO. 167:** An Act Allowing the Use of Motorcycles as Public Utility Vehicles, Amending for the Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code, and for other Purposes (Introduced by Sen. Joseph Victor G. Ejercito);
3. **SENATE BILL NO. 1004:** An Act Allowing and Regulating the Use of Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code, and for other Purposes (Introduced by Sen. Sonny Angara);
4. **SENATE BILL NO. 1328:** An Act Recognizing Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code and Republic Act No. 7160, Otherwise Known as the Local Government Code, as Amended, and for other Purposes (Introduced by Sen. Imee R. Marcos); and
5. **SENATE BILL NO. 1465:** An Act Allowing And Regulating the Use of Motorcycles as Public Utility Vehicles, Amending for this Purpose Republic Act No. 4136, Otherwise Known as the Land Transportation and Traffic Code, and for other Purposes (Introduced by Sen. Ramon Bong Revilla Jr.).
