PLAN (PBSAP)

This is in relation to the assessment and updating of the Philippine Biodiversity Strategy and Action Plan (PBSAP) in line with Kunming-Montreal Global Biodiversity Framework (KMGBF) adopted during the fifteenth meeting of the Conference of the Parties to the Convention on Biological Diversity (CBD COP15) in December 2022.

BMB is spearheading the conduct of nationwide consultation workshops and focus group discussions to be undertaken in a well participatory manner with key stakeholders both at the national and local levels. Cluster consultation workshops will be conducted with the following tentative schedules:
