This pertains to the letter dated March 10, 2023 of the Tenants of PWRCC stalls wherein a meeting was conducted on April 13, 2023, attended by previous lessees of stalls. Discussed during the meeting is their intent to rent again a commercial space for souvenir, canteen, and photo print shop, among other. The undersigned advised them that they will be notified as soon as the department approved the submitted business plan incorporating the said rental space projects.

In view hereof, this office recommends the opening and allowing the stalls at the PWRCC to operate for business. This will be another source of additional income to support the center operations. Hence, respectfully requesting a clearance to enter into a contract with potential investor to operate a business.
