Putting Tubig, Calapan City, Oriental Mindoro, alleging that there is an incident of oil spill coming from STX Corporation.

In view hereof, you are hereby directed to conduct an **immediate inspection, sampling, and coordination** with the concerned agencies on the abovementioned complaint. Your report with your recommendations must be submitted to this Office within 48 hours from the conduct of inspection.


