As previously mentioned in our letter dated 28 April 2023 (copy attached), we would like to reiterate that the area covered by Busuanga Pasture Reserve (BPR) is withdrawn from sale, settlement, or any other form of disposition, exploration or exploitation and reserved for pasture purposes only pursuant to Presidential Proclamation No. 1387 s. 1975.

In the absence of a law amending the said Presidential Proclamations, this Office will remain steadfast in its duty to enforce laws, rules, and regulations related to the administration of BPR pursuant to Presidential Proclamation No. 663 s. 2013.



Therefore, your proposal to use the portion of BPR for the purpose of fruit plantation is hereby denied since areas of BPR are reserved for pasture purposes only in line with the Presidential Proclamation No. 1387.
