Respectfully forwarded is the memorandum of CENRO Taytay Palawan dated May 25, 2023 relative to the above subject.

Per memorandum, CENRO Taytay submitted the spot report of the apprehended Ipil lumber of one thousand one hundred sixteen (1,116) pieces with a corresponding volume of sixteen thousand seventy one (16,071) board feet. The said lumber were apprehended by virtue of Search Warrants Nos. SW EJ No. 164-ROX-2023-02-TY and SW EJ No. 164-RX-2023-03-TY respectively in the two (2) warehouses within the residential compound owned by certain Eladio Parinas, Jr. for possessing of Ipil lumber without permit located at Sitio Ariman-an, Barangay Talog, Taytay, Palawan. The said Ipil lumber were hauled/transported at the DENR-CENRO Guest House Compound, Poblacion, Taytay, Palawan for safekeeping purposes.

Please be informed that personnel of this office applied for a Search Warrant on May 23, 2023 at the Regional Trial Court of Palawan-Fourth Judicial Region, Roxas, Palawan to search the warehouse in the residential compound and another warehouse in a separate location both owned by certain Eladio Parinas Jr. for possessing of lumbers without permit both located at So. Ariman-an, Barangay Talog, Taytay, Palawan. The Executive Judge granted/issued two (2) Search Warrants bearing Nos. SW EJ NO. 164-ROX-2023-02-TY and SW EJ NO. EJ No. 164-RX-2023-03-TY respectively.

On May 24, 2023, personnel of this office with the assistance of the Municipal Police Station-Taytay and Philippine Marines- 3<sup>rd</sup> Marine Company Battalion Landing Team 3 with the presence of Barangay Officials of Barangay Talog proceeded and served the Search Warrants to Mr. Eladio Parinas, however he is not around at that time and only the caretakers were present. Accordingly, Mr. Parinas travelled to Puerto Princesa City early morning on that day to accompany/assist his wife for medical check-up/operation.

In that instant, the team searched the above mentioned area and found several lumbers stockpiled in his warehouse in the residential compound and another separate warehouse. The lumbers were hauled and transported/deposited at the DENR-CENRO Guest House compound, Poblacion, Taytay, Palawan for safekeeping. Per scaling and inventory conducted disclosed there are 1,116 pieces of Ipil lumber with a corresponding total volume of 16,071.66 board feet. The search operation was peacefully implemented/conducted.

This office is now in the process of preparing the required documents/evidences for the filing of criminal charges against Mr. Eladio Parinas Jr. for violation Sec. 77 of PD 705 as further amended including Return of Search Warrant Report to be submitted to the Regional Trial Court, Roxas, Palawan. Likewise administrative adjudication in consonance with DAO 97-32 will be conducted soonest and progress/detailed report will be submitted upon completion.
