The Department through the Human Resource Development Service (HRDS), in coordination with the Environmental Law Enforcement and Protection Service (ELEPS), is currently implementing the Environment and Natural Resources (ENR) Specialized Course on Environmental Law Enforcement (SCELE) Batch V which aims to capacitate the learners with ENR related competencies and strengthen the coordination of various stakeholders in the enforcement of ENR laws in forestry, wildlife, protected area, coastal and water resources.
