Greetings in pursuit of agricultural excellence!

The Bureau of Soils and Water Management (BSWM) in partnership with the Department of Environment and Natural Resources (DENR) is currently implementing a GEF6-funded project on "Integrated Approach in Management of Major Biodiversity Corridors in the Philippines" in the Mindoro Biodiversity Corridor (MBC). The project aims to address land degradation and the impacts of agriculture as a driver of forest fragmentation through the promotion of Sustainable Land Management (SLM) measures and biodiversity-friendly agricultural practices (BDFAPs).

The initial data from the national land degradation maps of 2020 showed that portions of the province's cropland area were identified with negative trends of land degradation. From this data, we have selected some municipalities as part of the initial list for validation in the establishment of an exemplar site which will showcase SLM technologies covering an area of 3-5 hectares. In line with this, our office will conduct an Orientation and Consultation Workshop on the Selection of Exemplar Sites to orient the LGUs on the objectives and implementing guidelines of the project. This workshop also aims to consult the stakeholders on possible areas of the exemplar sites in their respective biodiversity corridors.

Anent to this, we would like to invite you to the orientation and consultation workshop on May 9, 2023, in Puerto Galera, Oriental Mindoro. The workshop venue will be announced at a later date.
