Muli kaming dumudulog sa inyong butihing tanggapan upang ipabatid po sa inyong kaalaman ang aming pagka-dismaya, at pagkokondena sa prosesong ginawa ng inyong ahensya hinggil sa Lot 478 at 479 Pls-395-D na matatagpuan sa Brgy. Cambunang, Bulalacao, Oriental Mindoro na kung saan ang nasabing lupain ay may aplikasyon ng yumaong Pedro Solis 1936 pa, batay sa isang resolution ng DENR Region Legal Division at nais naming malinawan at mabigyan ninyo ng tamang kasagutan ang mga sumusunod na katanungan;

1. Nais po naming malinawan kung anong ang kanilang pinagbatayan para hahantong sa isang disisyon na pumapabor sa mga apo ni Pedro Solis?

Ayon sa nasabing resolution (1993) ito ay ibinatay sa Act 3038 under provision sa Act 2874 (Public Land Act) na ginamit sa Insular Government Property Sales Application (IGPSA) na nakasaad ang mga sumusunod:

Sa talata 2;

Na may binayaran sya na Php 615.36 at Php 1,200.00 (Tax Dec.) para sa 40 ektaryang lupain;

Batay sa cadmap at technical description ang 2 parsesa ay may sukat na 9.2037 ektarya at 144368 ektarya;

Kung 40 ektarya saan po ang ibang kakulangang ektarya pa? Ibig sabihin hindi sigurado sa kanilang ginawang aplikasyon;

Sa talata 3;

Nakasaad sa nasabing resolution 1920s ng unang tumungtong si Pedro Solis sa nasabing lupain pero sya ay nawalan ng pagkakataon (forfeited) dahil sa bisa ng isang hatol writ of execution bilang parusa sa kasong kriminal Case No. 2057;

Tanong, kung nawalan ng pagkakataon at may execution bakit muling hinayaan ng ahensyang makapagpasa ng aplikasyon sa parehong lupain sa parehong lugar?

Sa DAR na isa ring government agency kapag nahatulan ang isang individual ay hindi na maaaring maging binipisyaryo ng programa ng gobyerno hindi ko po alam sa DENR, with the same status as government agency.

Sa talata 16;

Malinaw po ang pagbibigay diin kung tama ba na si Pedro Solis ay may karapatan na magmamay-ari ng lupain na makuha dahil sa I.G.P.S.A?

Anong batayan ng Legal Division Regional Office at CENRO para masabi nila na nararapat na si Pedro Solis ang mapagkalooban ng nasabing lupain?

Malinaw sa Act 3038 under provision Act 2874 section 30;

“Before any patent is issued, the purchaser must show actual occupancy, cultivation, and improvement of at least one-fourth of the land applied for until the date on which the final payment is made.(As amended by section 5 of Act No. 3517);

For as we know, hindi nakapagbungkal ng nasabing lupain ang Pedro Solis dahil ang mga actual na possessioners, cultivators na syang naging biktima ng pananamantala nila ang syang tunay na nasa erya nagbubungkal nagpayaman ng nasabing lupain. Ano ang patunay ng actual na pamomosisyon ni Pedro Solis sa nasabing lupain at saan ang kanyang na develop na erya? Nakakagulat,nakakalungkot isipin na mananaig ang kasinungalingan kaysa katotohanan.

Ayon sa po sa Rule No.10, section 46 (A12) Revised Rules on Administrative Cases in the Civil Service;

“Disloyalty to the Republic of the Philippines and to the Filipino people” ay may kaparusahang kaakibat kung kaya’t kami ay naghuhumiaw ng hustisa,tamang proseso at makatotohanang imbestigasyon para sa mga actual na possessioners,tillers ng nasabing lupang sakahan.

Ayon po sa kawani ng CENRO sila ay sumusunod lamang sa mando o utos mula sa inyong tanggapan magkagayon po tama po kaya ang inyong iniuutos sa kanila? O idinahilan lamang nila ang inyong tanggapanupang pagtakpan ang kanilang kamalian sa pagsasa-ayos sa nasabing isyu?

Sa Legal Division at CENRO nagkaroon po ba ng pag published at actual inspection ba sila batay sa requirements na nakasaad sa IGPSA?

Kasi kung nagkaroon impossible na hindi nila makita ang pamomosisyon ng mga magsasaka na actual na nagsasaka, ang bahay na nakatirik sa nasabing lupain.

Ito po ay isang hamon sa inyong kakayahang bilang mga government employees as stated on **Article XI section 1 of 1987 Constitution;**

“Public office is a public trust. Public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, integrity, loyalty and efficiency, act with patriotism and justice and lead modest lives”;

How can we trust if we see fraud, erroneous mispresentation of beneficiary?

Article III section 1 of 1987 Constitution;

“ No person shall be deprived of life, liberty, or poverty without due process of law, nor shall any person be denied the equal protection of the law”;

Tanong: Legal Division at CENRO bakit hinayaan ninyong maisantabi ang karapatan ng mga actual possessioners, cultivators? Dahil ba sa dekadang application ni Pedro Solis? Gaano kayo kasigurado na wala kayong nilabag na karapatan ng mga actual possessioners and cultivators? Kayo po ba ay actual na pumunta sa erya o nagbabase lamang sa isinumiting dokumento?

Kgg. Na Secretary Loyzaga, kami po ay humihiling ng isang actual ocular inspection na kung saan ito ay magmula mismo sa inyong tanggapan upang mabatid ninyo kung anong kalukuhang pinaggagawa ng inyong mga kawani, hinihiling din namin na mabigyan ng pagkakataon ang mga aktwal posiyuner na maging pag-aari na nila ang nasabing public land na ito ay maipagkalooban ng titulo sa kanilang mga pangalan.

Hinihiling din namin na mabigyang kasagutan ang aming katanungang na ang pangungulekta po ba ng pera ni Pancho Solis sa mga actual possessioner ay may pahintulot mula sa inyong ahensya? Ito po ba ay legal at nararapat nyang gawin?

Kung hindi anong kaparusahan ang maaaring ipataw ng inyong ahensya sa kanyang pananamantala sa mga actual possessioners? Milyong halaga na po ang nakulektang pera ni Pancho Solis mula sa mga actual possessioners and cultivators. Ito ay isang kalapastangan na hindi pa nga pag-aari na pinoproseso pa lamang at may nagprotesta sana mabigyan ng hustisa ang mga nakuhanan ng pera at parusahan ang dapat parusahan.



Kung walang tinatagong kababalaghan bakit hindi kami bibigyan ng nasabing kopya? At sa aking pagkaka-alam wala pang naipagkaloob na titulo bakit kami sa korte mag aapela? Ito ay jurisdiction ng DENR as a government agency in charge on public lands kaya **Kgg. Na Secretary Loyzaga** nawa kami ay inyong pakikinggan at pagbibigyan sa aming mga kahilingan. At para sa inyong kabatiran din po kami ay tinutulungan na rin ng aming butihing **Punong-Bayan Hon. Mayor Engr. Ernilo C. Villas ng bayan ng Bulalacao, Oriental Mindoro** upang ang nasabing lupang sakahan ay maipagkaloob mismo sa mga actual na nagsasaka.

Kalakip po ng aming liham ay ang mga larawan ng actual na mga magsasaka at ang kanilang bukid na sinasaka na kabilang sa Lot 478 at 479 Pls-395-D, skitch plan ng bawat sukat na kanilang sinasaka patunay na sila ang nararapat pagkalooban ng karapatan na mapasa-kanila ang nasabing lupang sakahan.

Umaasa po kami na ang aming kahilingan ay inyong mabigyan ng agarang tugon at aksyon.




